We want to hear about your experiences with the scheme, what is working, what is not working, and how we can make the scheme better. Once we have collected all of your views on the scheme, we will be in touch later this year to discuss some potential options for updating the scheme.

Draft Crown engagement strategy

The Minister for Treaty of Waitangi Negotiations recently approved engagement on a draft strategy to progress Crown engagement applications under the Marine and Coastal Area (Takutai Moana) Act 2011.

The draft strategy proposes that applications are progressed in clusters along sections of the coastline, coordinating engagement across all applications in that area. The strategy also sets out which areas of the coastline would be considered initially and in what order.

We want to hear your views on the draft strategy to ensure we fully understand the implications of this strategy for you, and how we might be able to assist you to progress your application prior to, and during engagement with the Minister. Once we have your input, we will review the strategy and seek final decisions from the Minister.
