Letter of Agreement to Amend Clause 8.69 of Te Pua o Te Riri Kore, the Ngāti Hāua Deed of Settlement

This letter is between the trustees of Te Whiringa Kākaho o Ngāti Hāua (the post-settlement governance entity for Ngāti Hāua) on behalf of Ngāti Hāua, and myself, as the Minister for Treaty of Waitangi Negotiations, on behalf of the Crown.

It records an agreement to amend clause 8.69 of Te Pua o Te Riri Kore, the Ngāti Hāua Deed of Settlement (the Deed), by removing the official geographic name change for the locality "Ongarue" to "Ōngaaruhe".

Background to the amendment

The official geographic name change for "Ongarue" locality and "Ongarue River" were included in the Crown offer on completion of the overlapping interests consultation conducted by Ngāti Hāua and the Crown in December 2023. The consultation included Te Nehenehenui (the Ngāti Maniapoto post-settlement governance entity) and other relevant post-settlement governance entities.

The Deed was initialled on 21 November 2024 and signed on 29 March 2025. Shortly prior to the Deed signing and during the Māori Affairs Committee public consultation on the Ngāti Hāua settlement legislation, Ngāti Raerae (a hapū of Ngāti Maniapoto represented by Te Nehenehenui) raised concerns regarding these official geographic name changes.

In August 2025, Te Whiringa Kākaho o Ngāti Hāua informed the Crown that they had reached an agreement with Ngāti Raerae relating to the locality name and wished to withdraw the official geographic name change for the locality "Ongarue" from the Deed. This withdrawal would not affect the official geographic name change for the "Ongarue River".

Amendment Effected for Deed

The Deed is amended by deleting the row in the table at cl 8.69 as shown by the struck-out text below:

"8.69. The settlement legislation will, on the settlement date, provide for each of the names listed in the second column to be the official geographic name for the features set out in columns 3 and 4.
