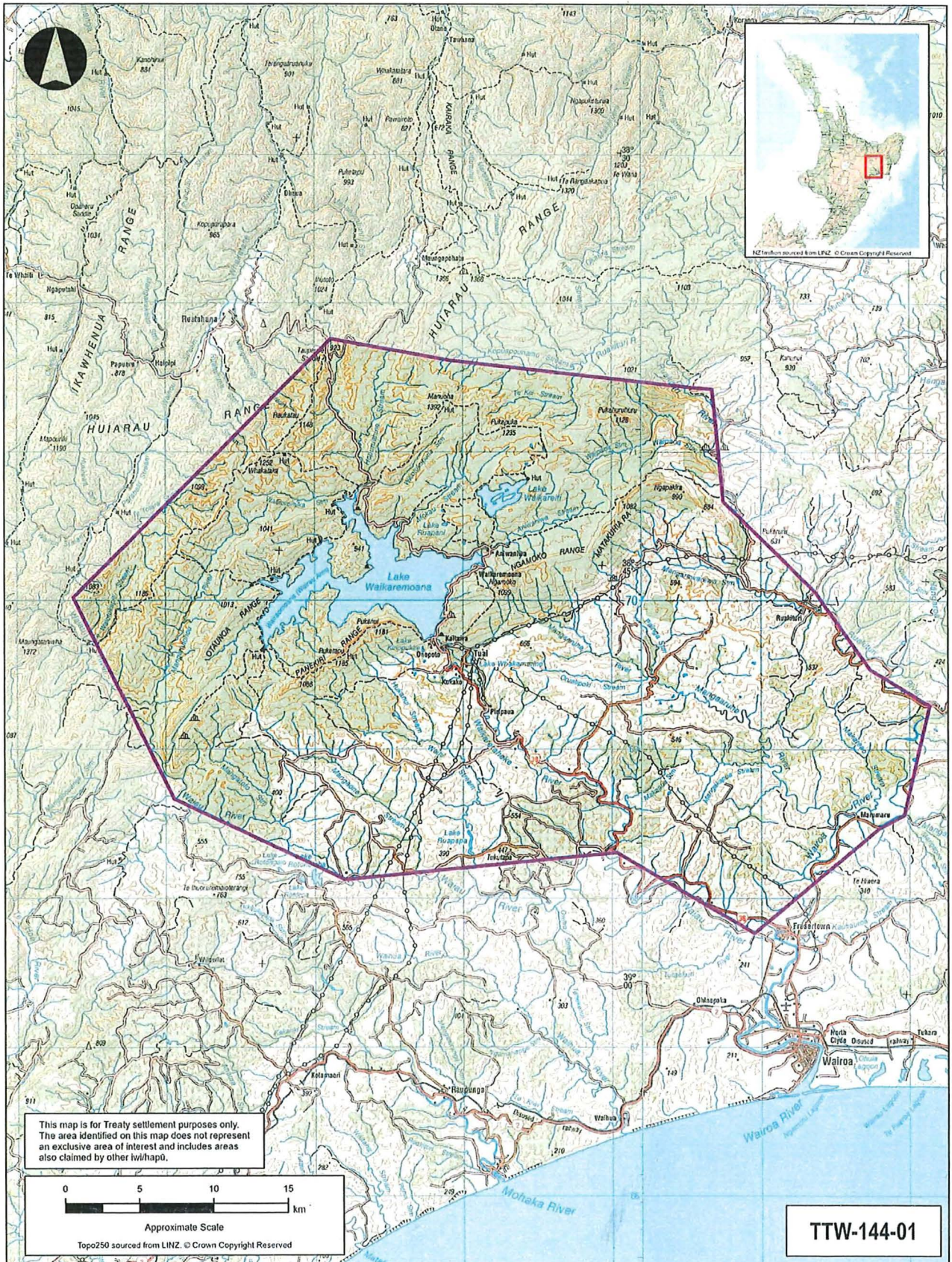

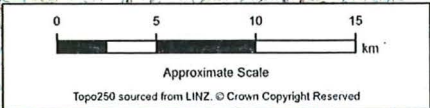

This map is for Treaty settlement purposes only. The area identified on this map does not represent an exclusive area of interest and includes areas also claimed by other iwi/hapū.





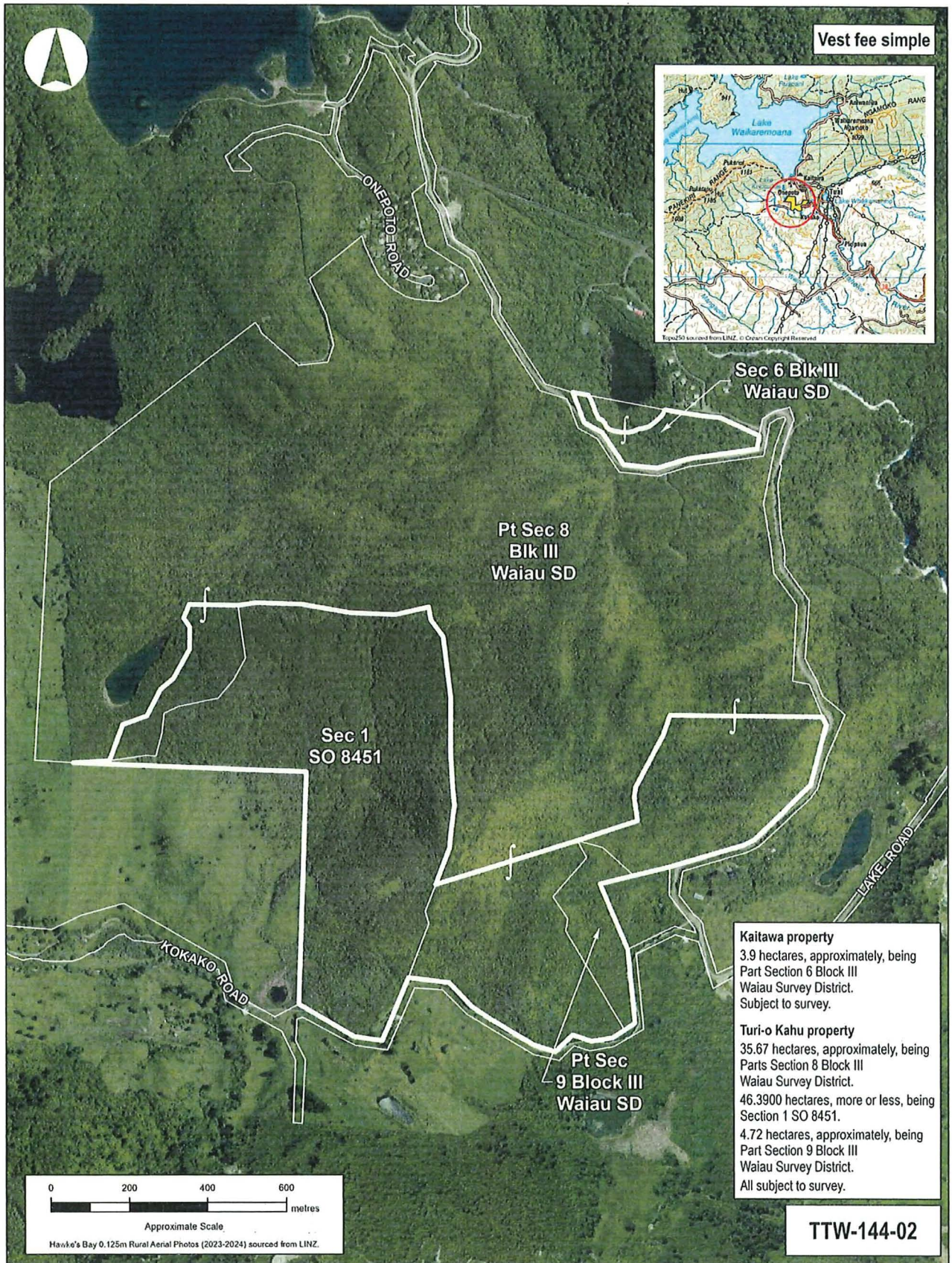

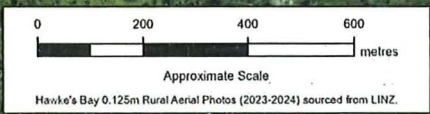
