DEED OF ACCESSION

THIS DEED is made between

NGĀI TAI KI TĀMAKI

and

THE CROWN

BACKGROUND

- A. Ngā Mana Whenua o Tāmaki Makaurau and the Crown entered into a collective redress deed dated 8 September 2012 (the “**collective deed**”).
- B. Ngāi Tai Ki Tāmaki signed the collective deed subject to undergoing a ratification process for the members of Ngāi Tai ki Tāmaki to ratify the collective deed and the collective governance entities to receive the redress, to the satisfaction of the Crown.
- C. Ngāi Tai Ki Tāmaki have, since the signing of the collective deed, by a majority of –
- [63.38]% ratified the collective deed and approved the signing of this deed; and
 - [63.38]% approved the collective governance entities receiving the redress.
- D. Each majority referred to in C above is of valid votes cast in a ballot by eligible members of Ngāi Tai Ki Tāmaki.
- E. The Crown is satisfied with the ratification and approvals.
- F. Part 12 of the collective deed provides for accession by Ngāi Tai Ki Tāmaki to the collective deed once those ratifications and approvals have been obtained and the Crown is satisfied with them.

IT IS AGREED as follows:

1 ACCESSION

- 1.1 Ngāi Tai Ki Tāmaki and the Crown record that –
- 1.1.1 this deed is the deed of accession for the purposes of part 12 of the collective deed; and
 - 1.1.2 clauses 12.4 to 12.6 of the collective deed apply accordingly.

2 INTERPRETATION

- 2.1 Unless the context requires otherwise:
- 2.1.1 **mandated signatories** means the individuals who signed this deed;

- 2.1.2 other terms or expressions defined in the collective deed have the same meanings in this deed; and
- 2.1.3 the rules of interpretation in the collective deed apply (with all appropriate changes) to this deed.
