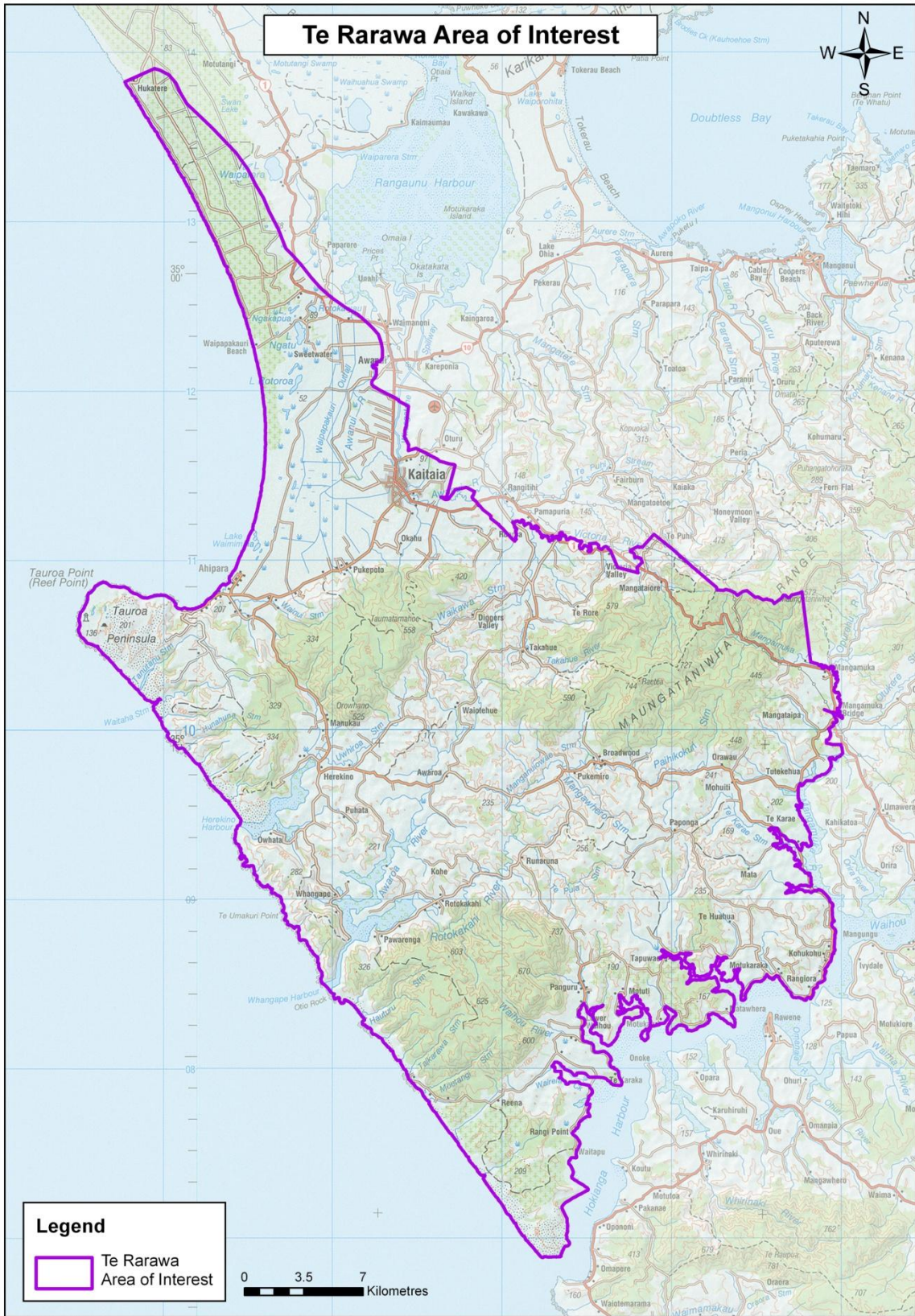

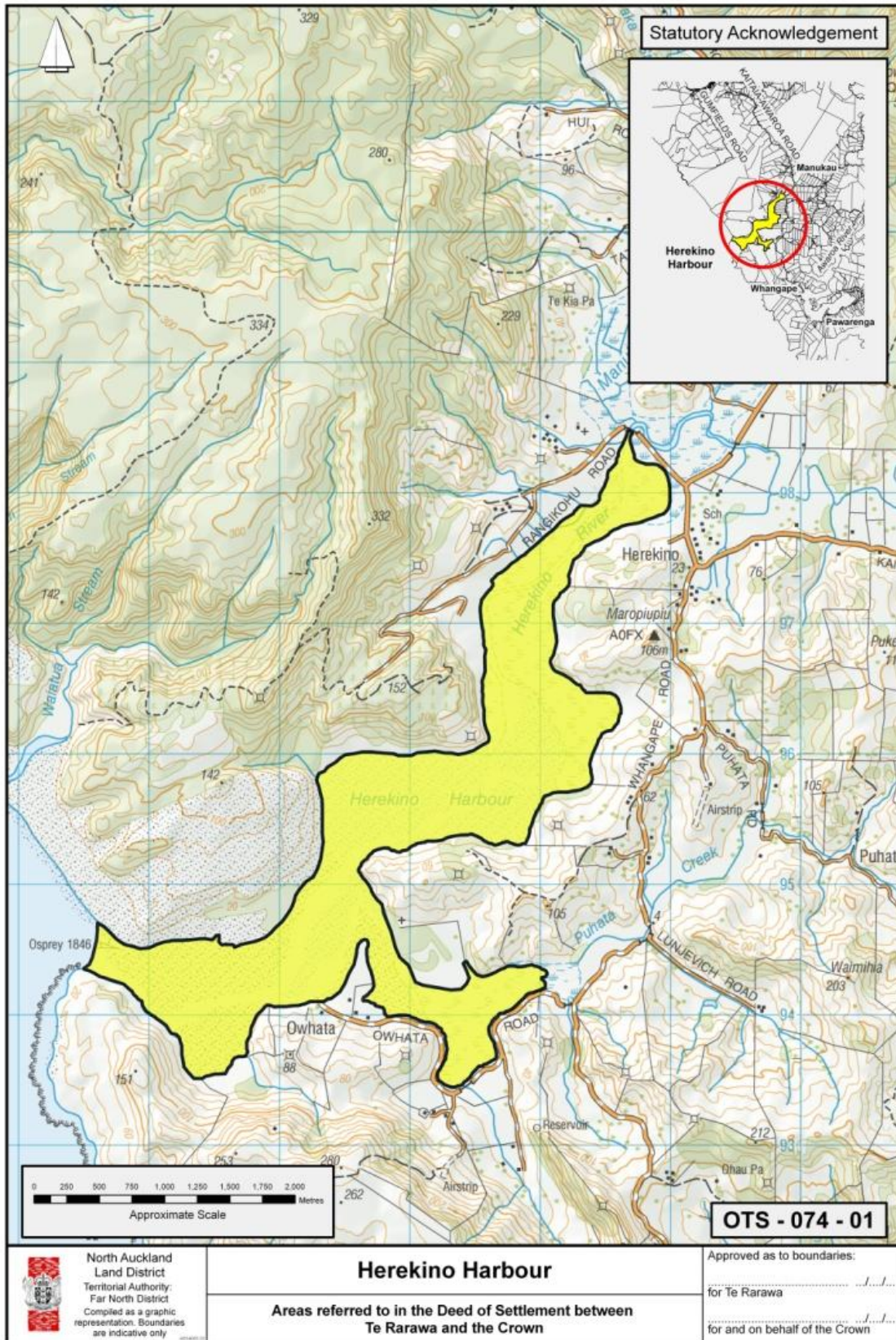

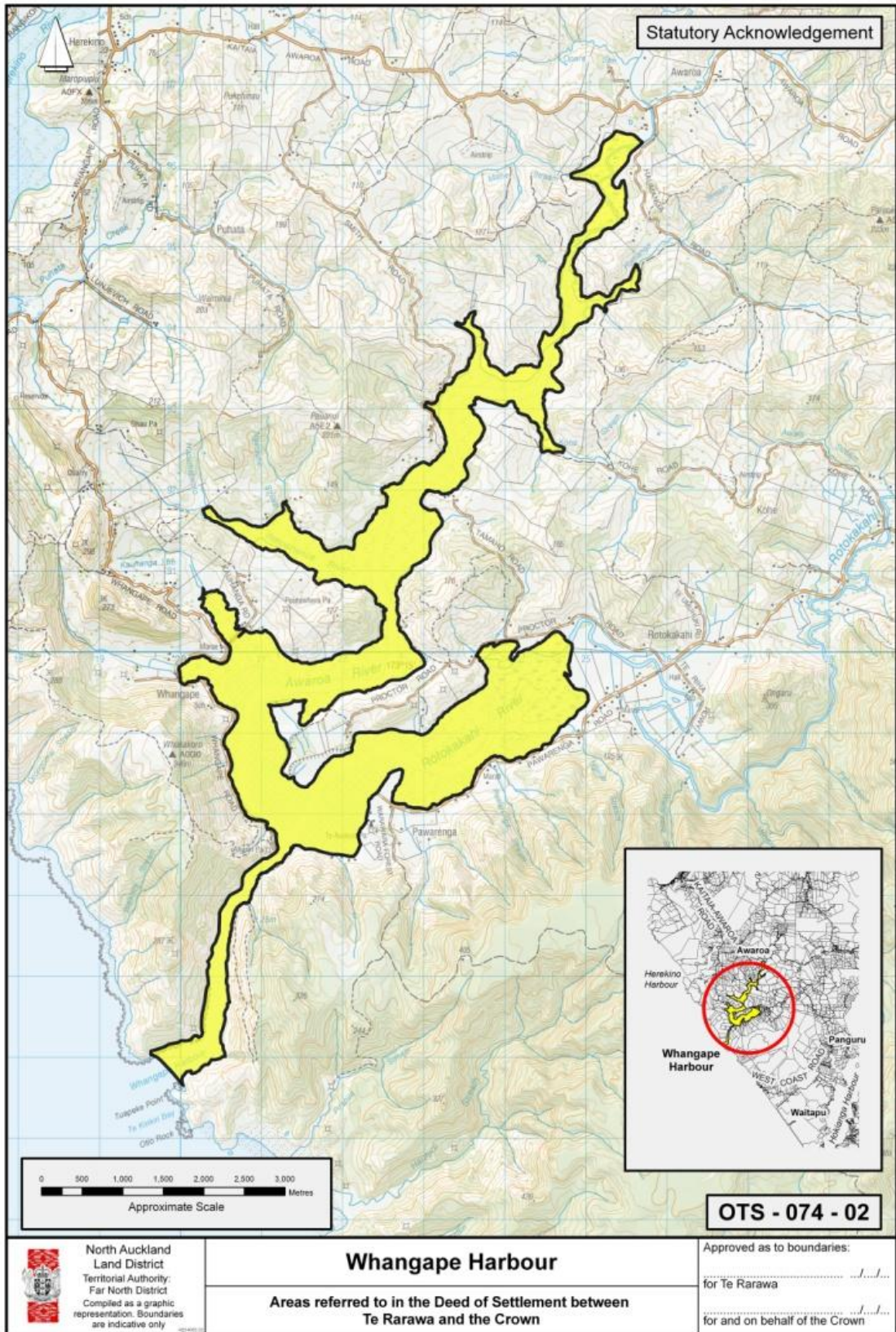
HEREKINO HARBOUR (OTS-074-01)

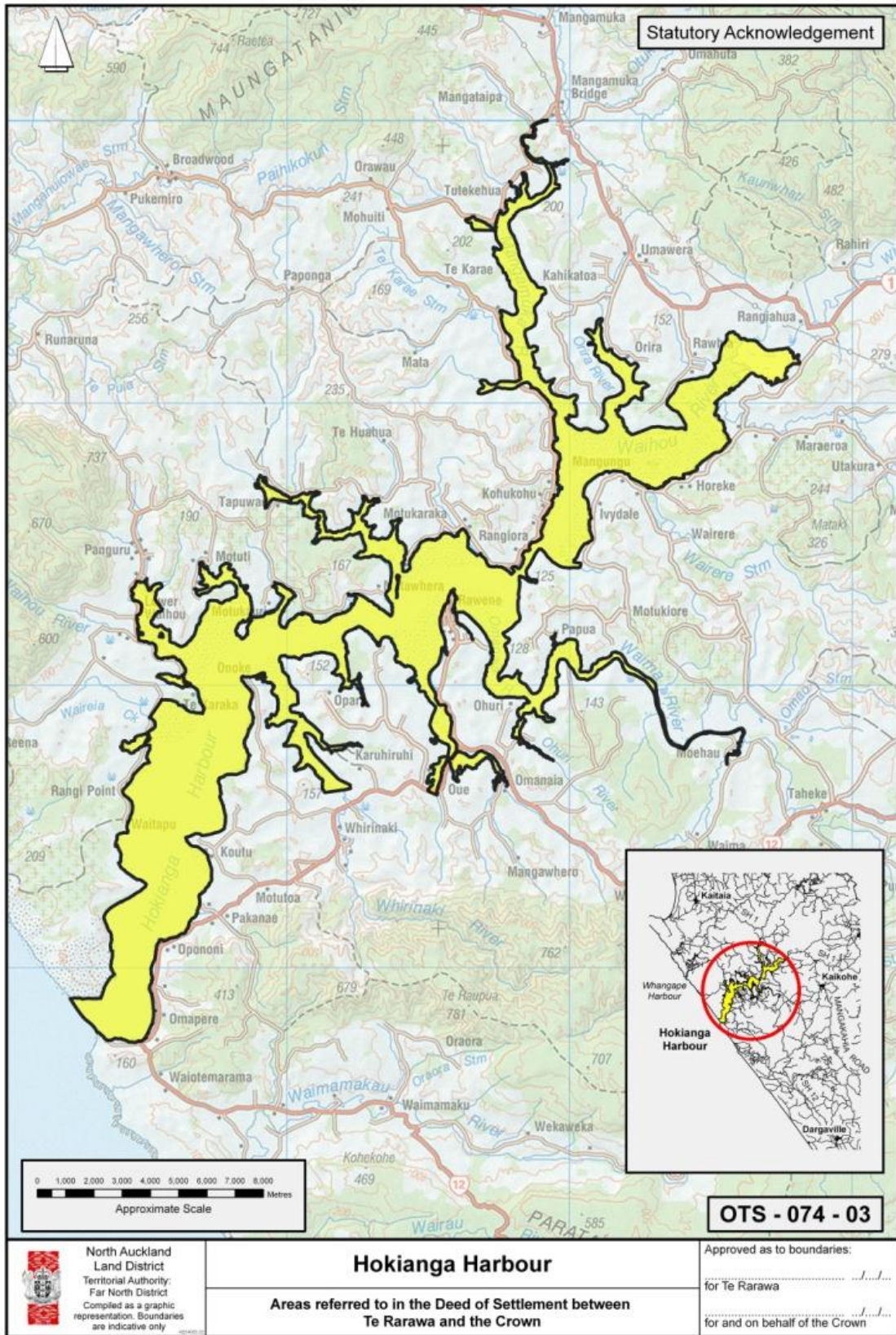
WHANGAPE HARBOUR (OTS-074-02)

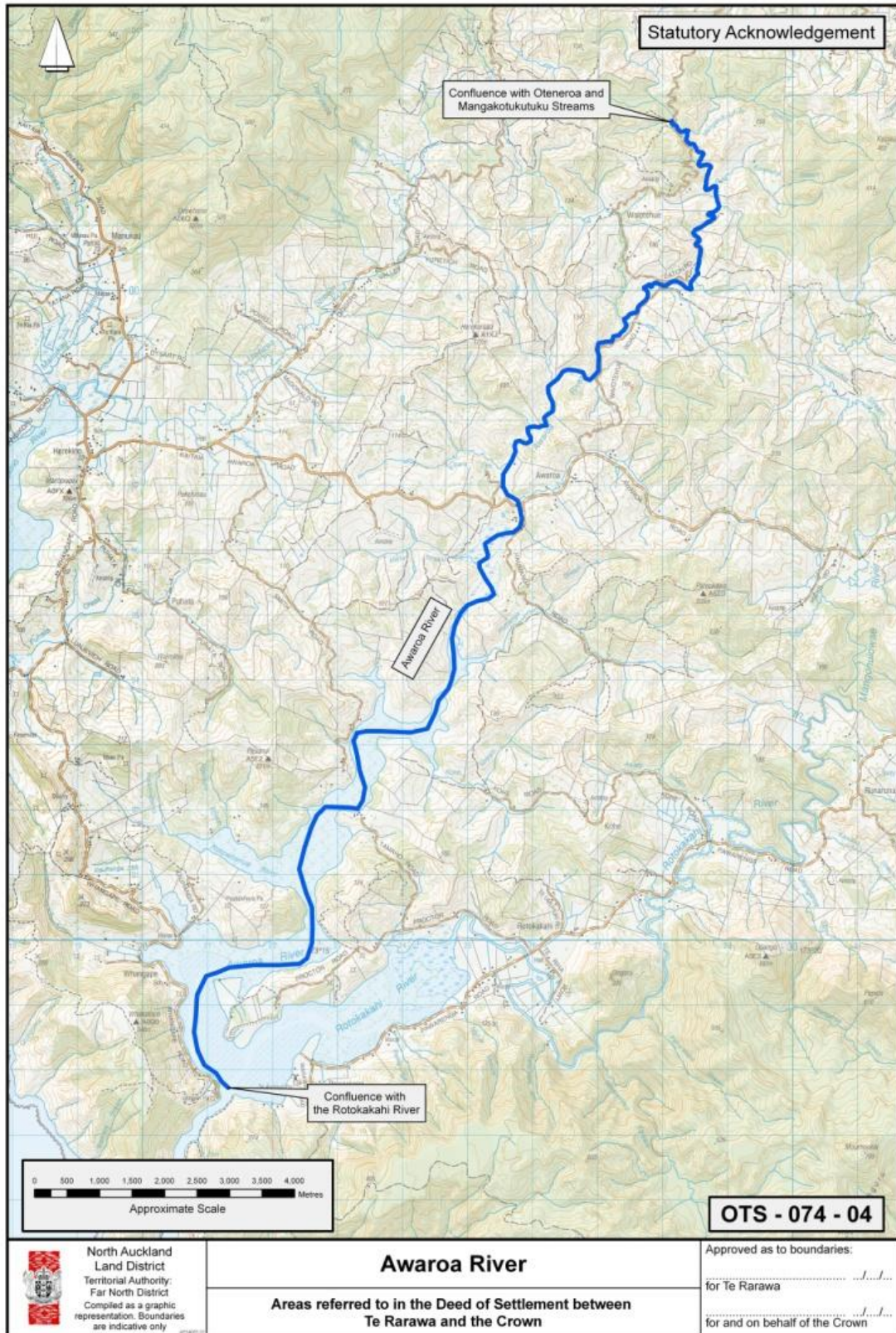

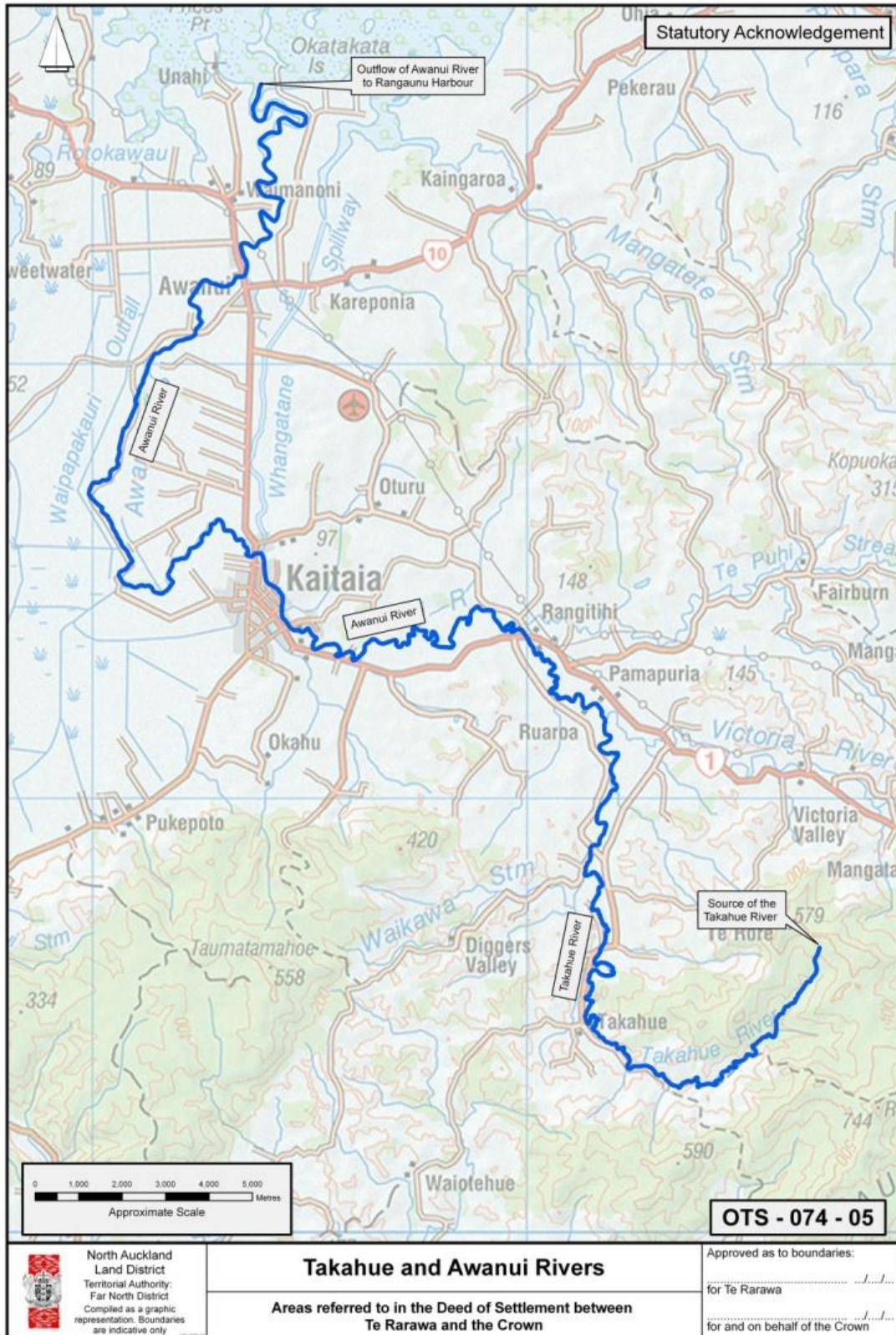

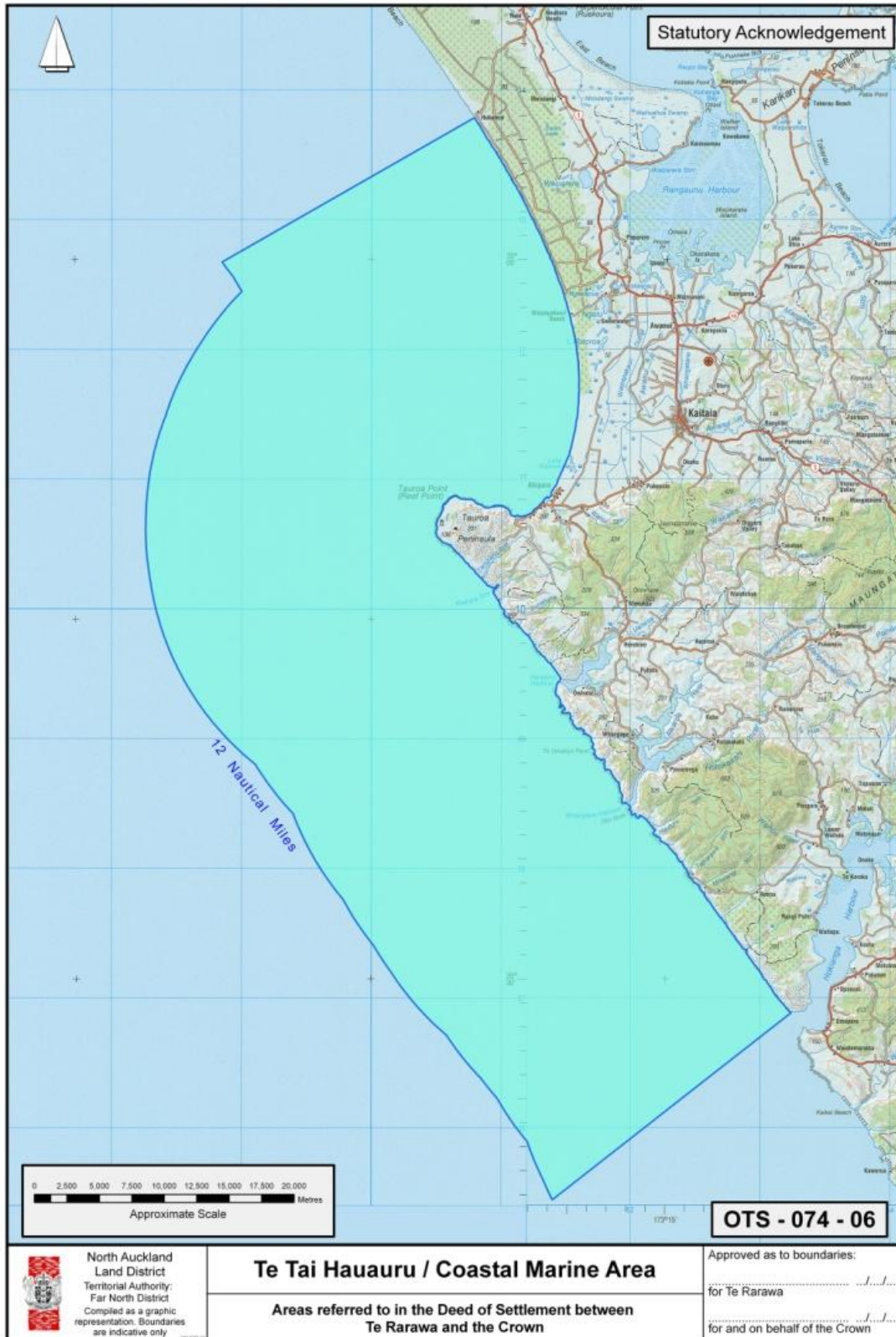
TAKAHUE AND AWANUI RIVERS (OTS-074-05)

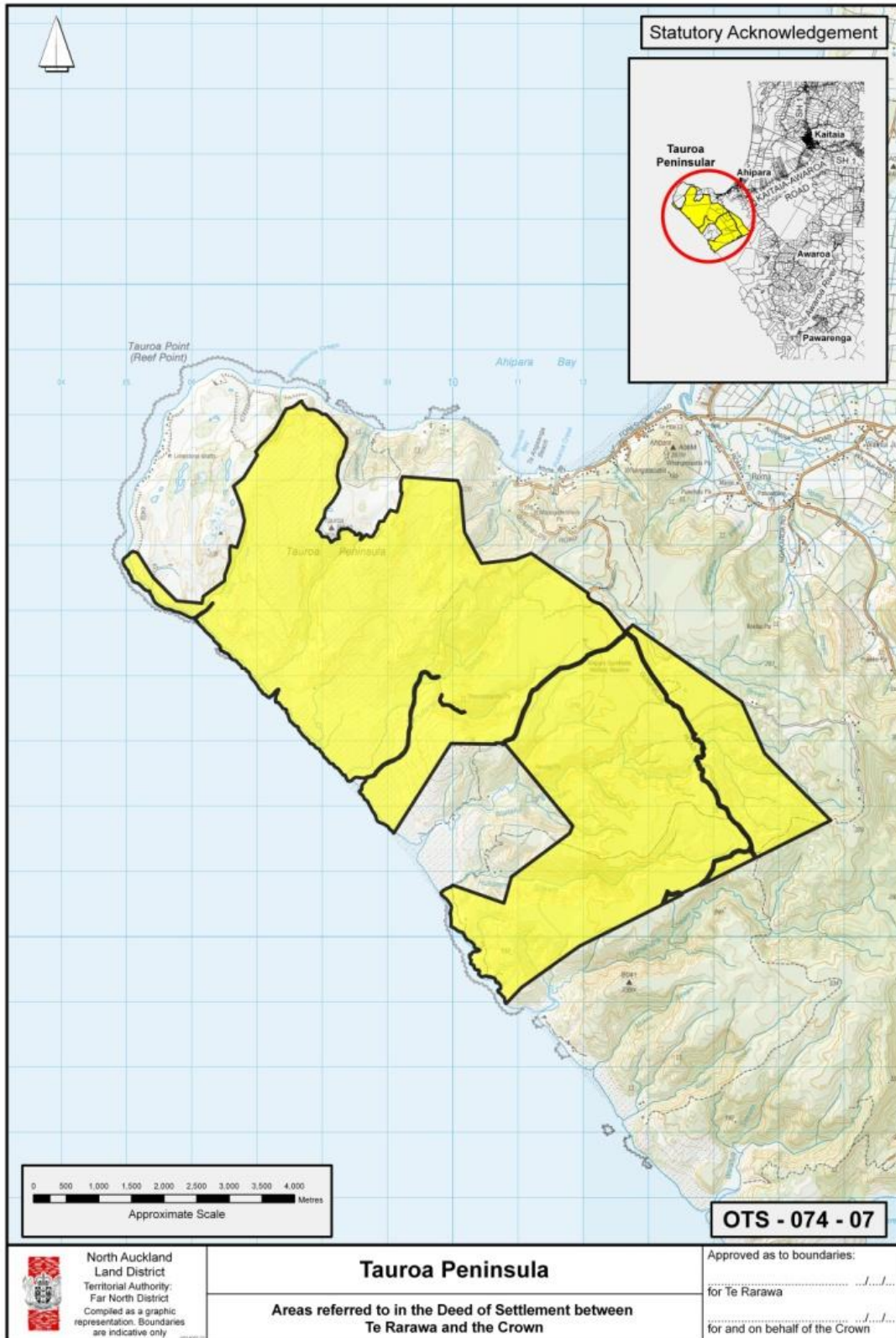
TE TAI HAUURU / COASTAL MARINE AREA (OTS-074-06)

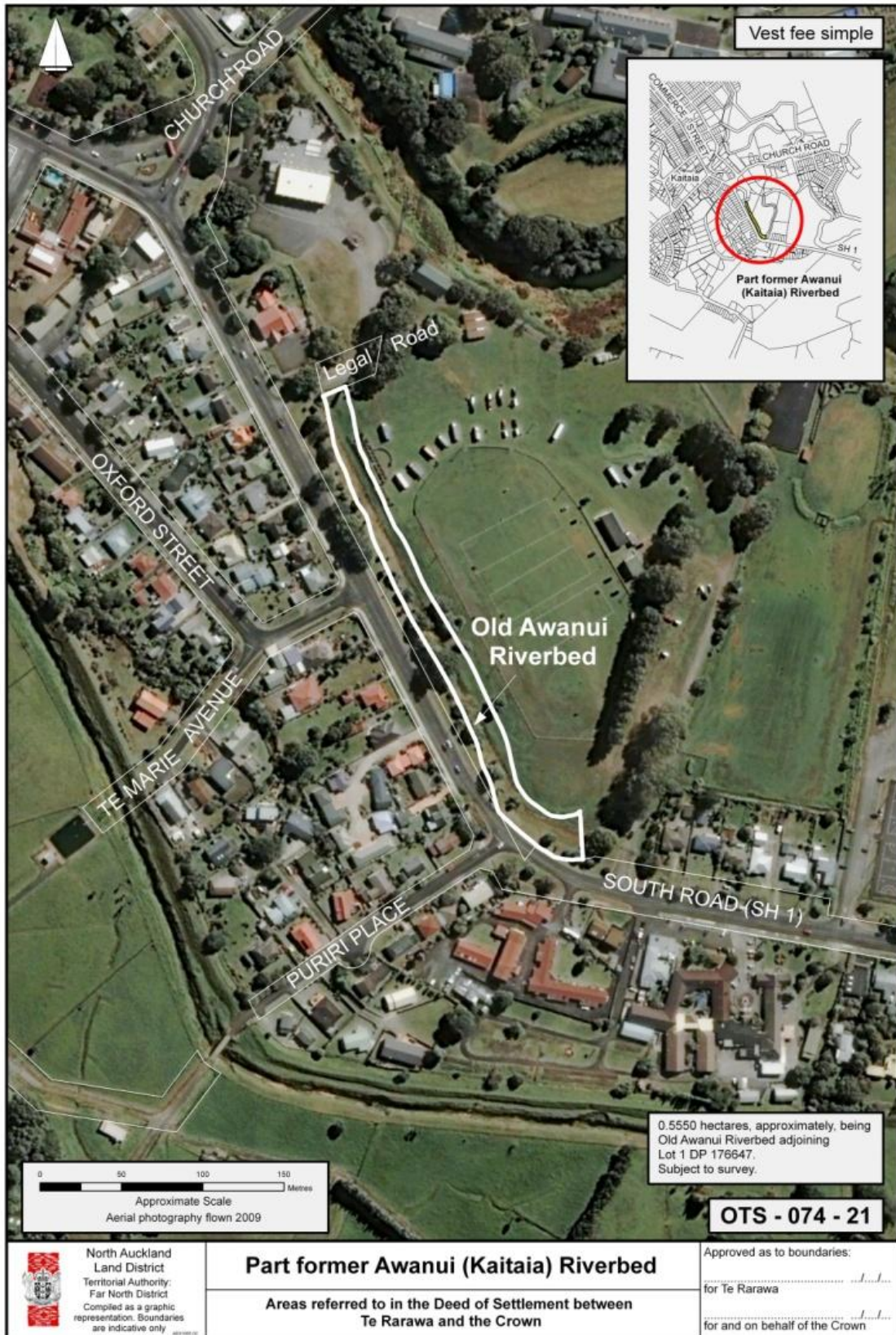

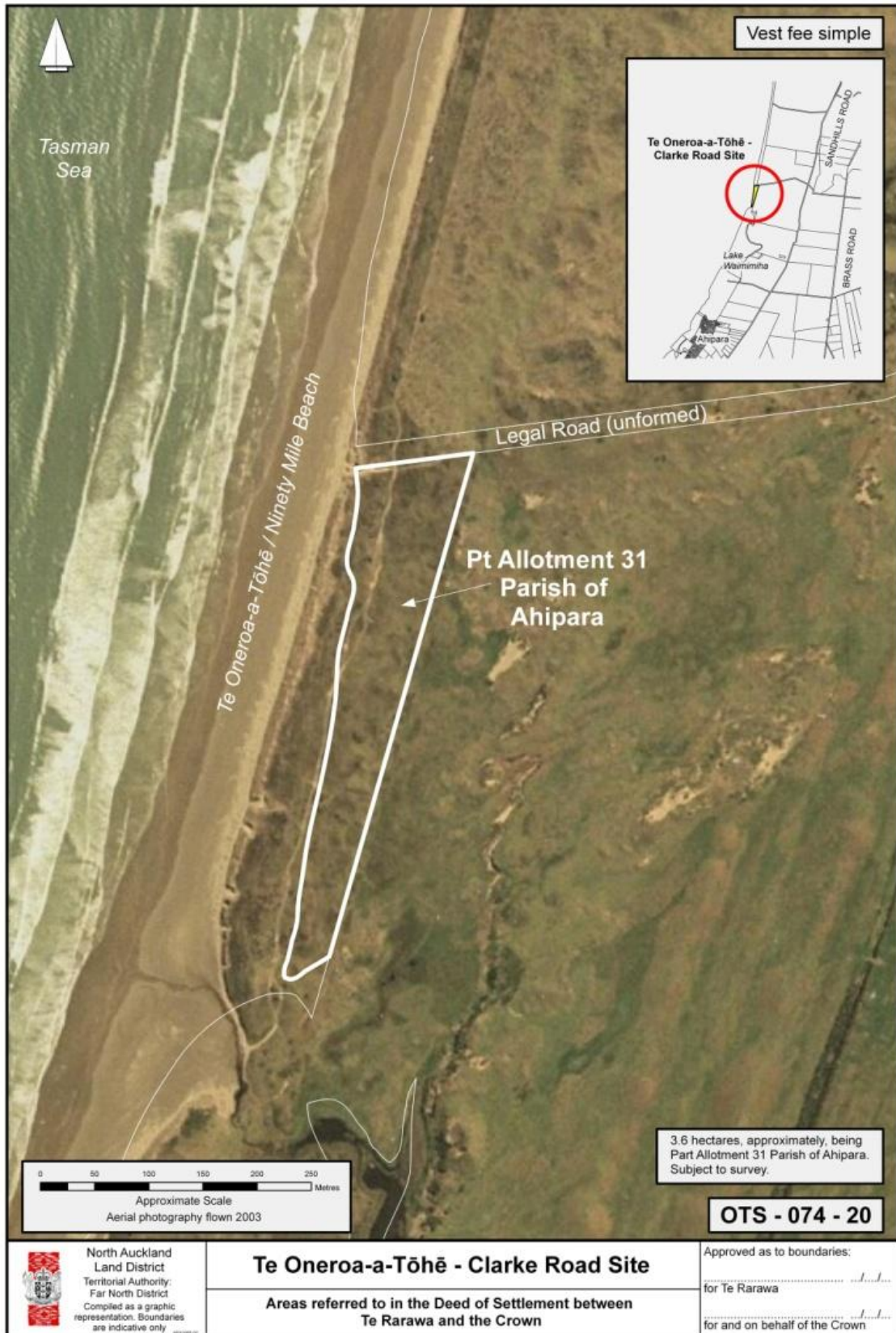
PART FORMER AWANUI (KAITAIA) RIVERBED (OTS-074-21)

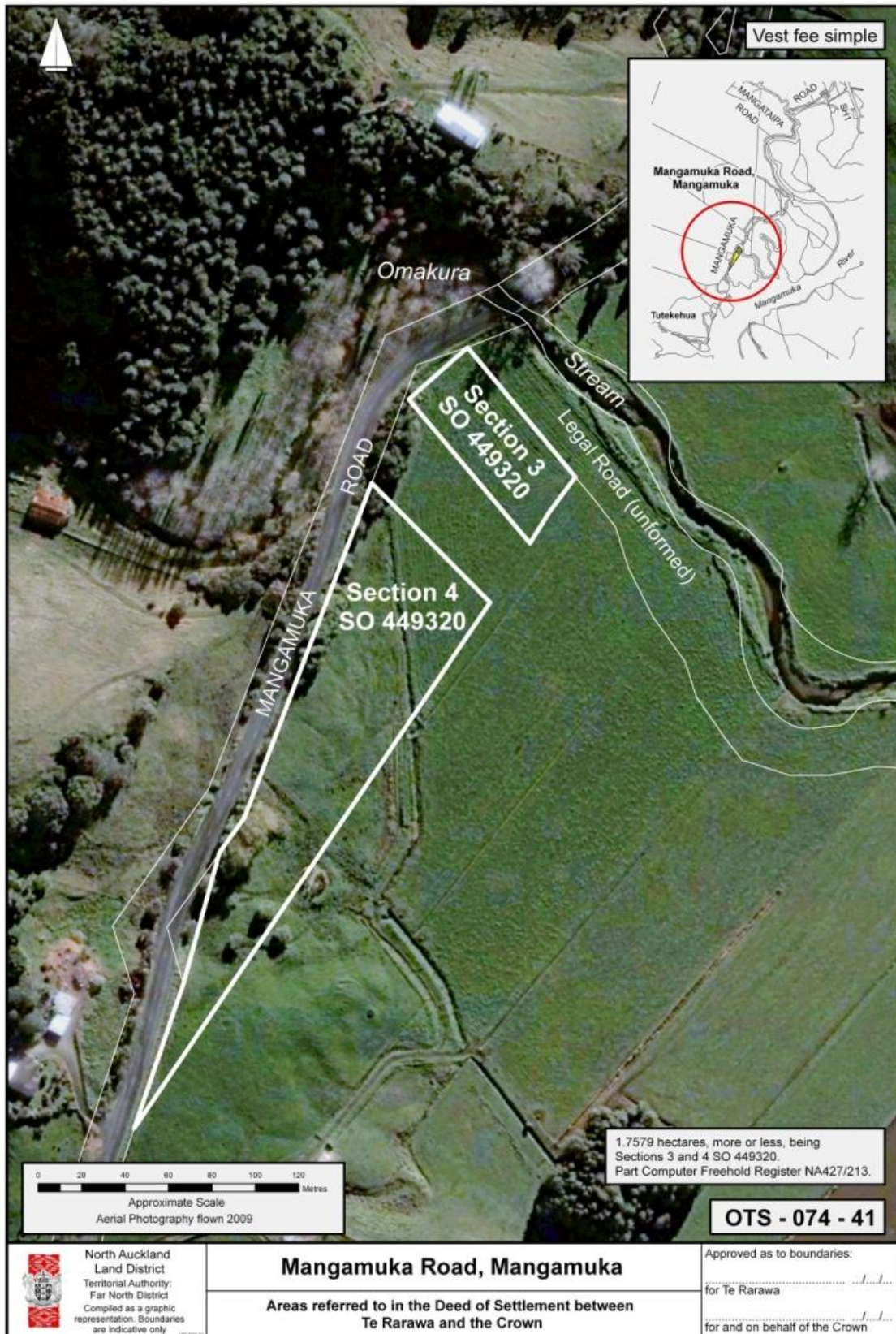
TAUROA POINT SITE C (OTS-074-36)

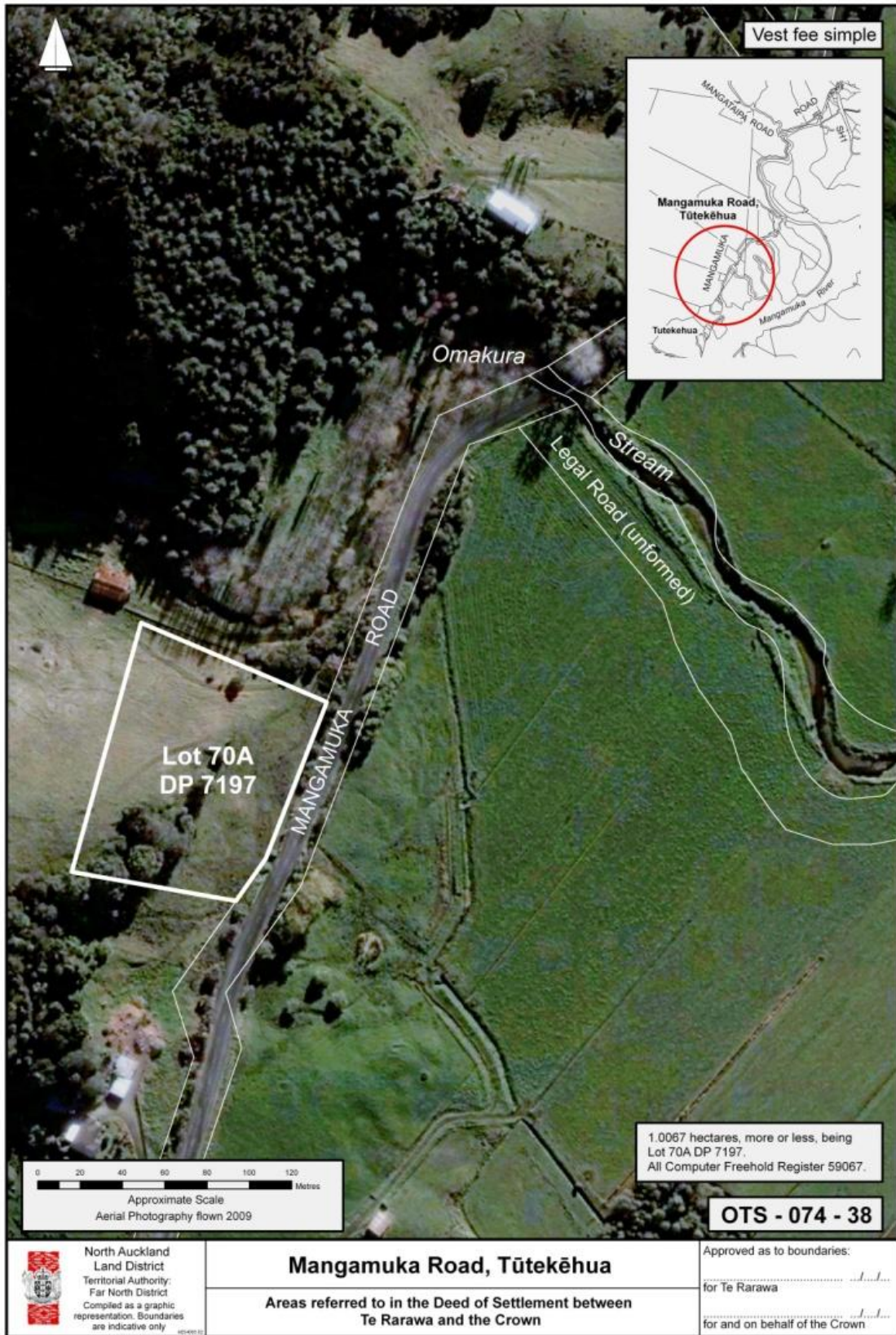

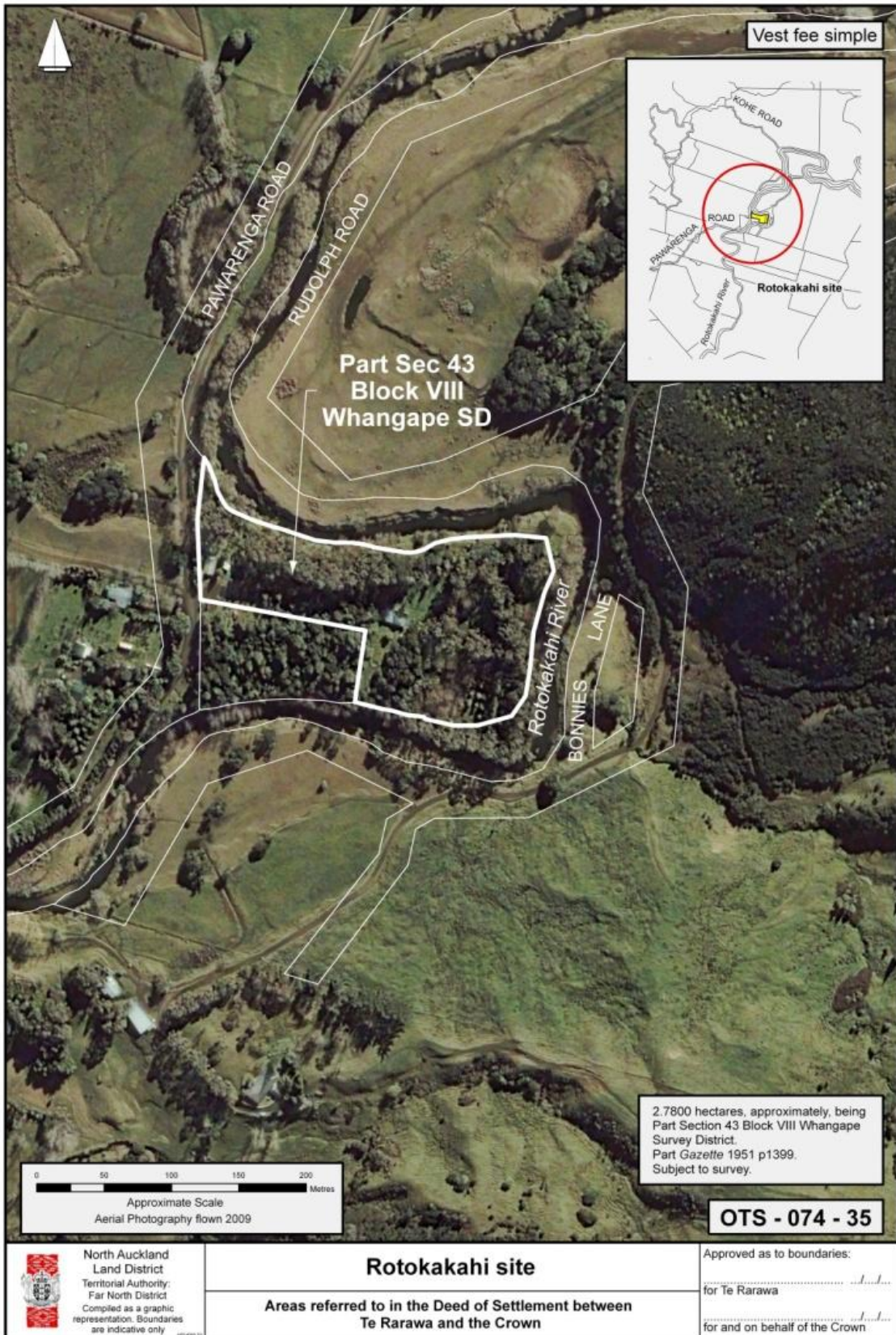
MANGAMUKA ROAD, TŪKTEKĒHUA (OTS-074-38)

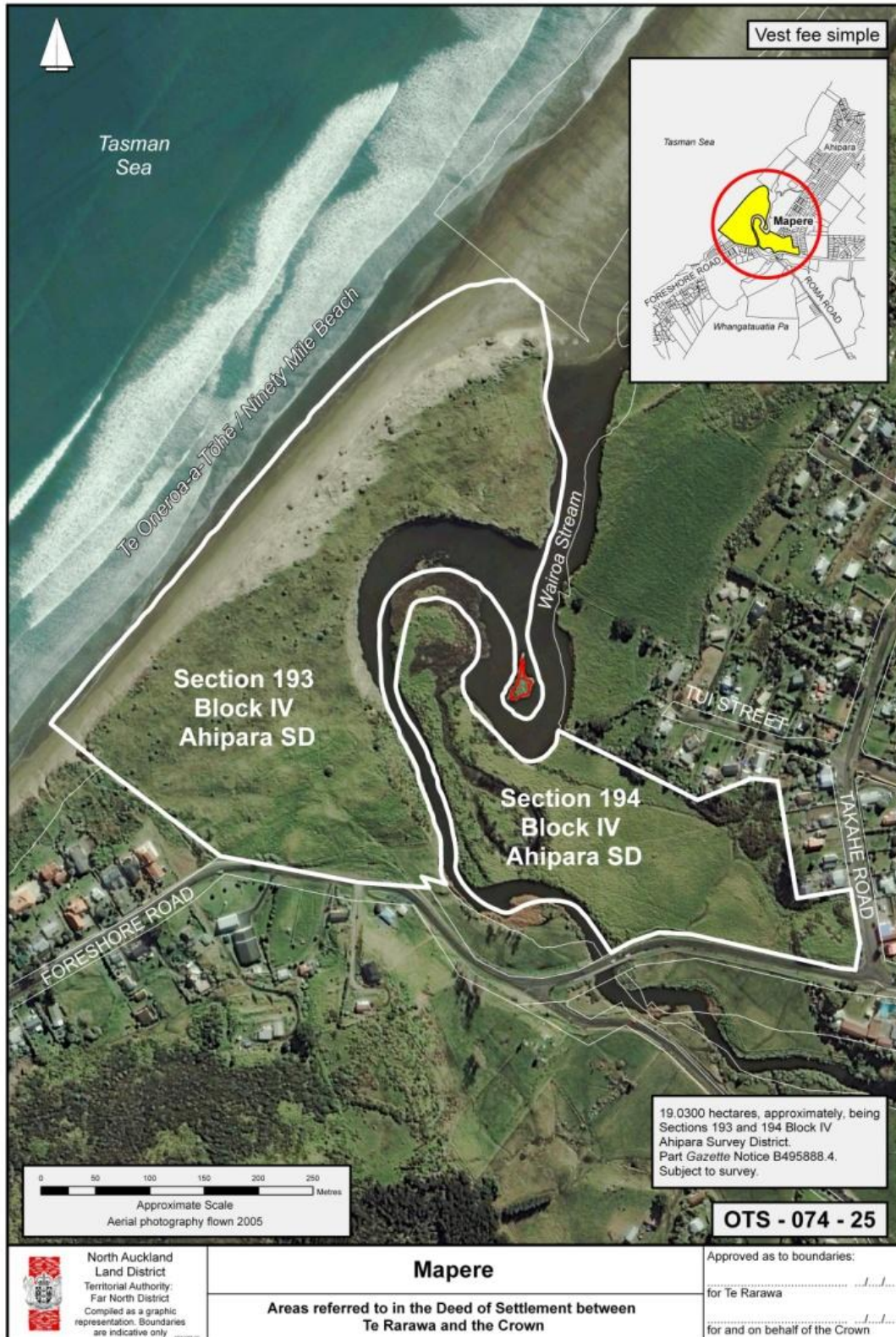

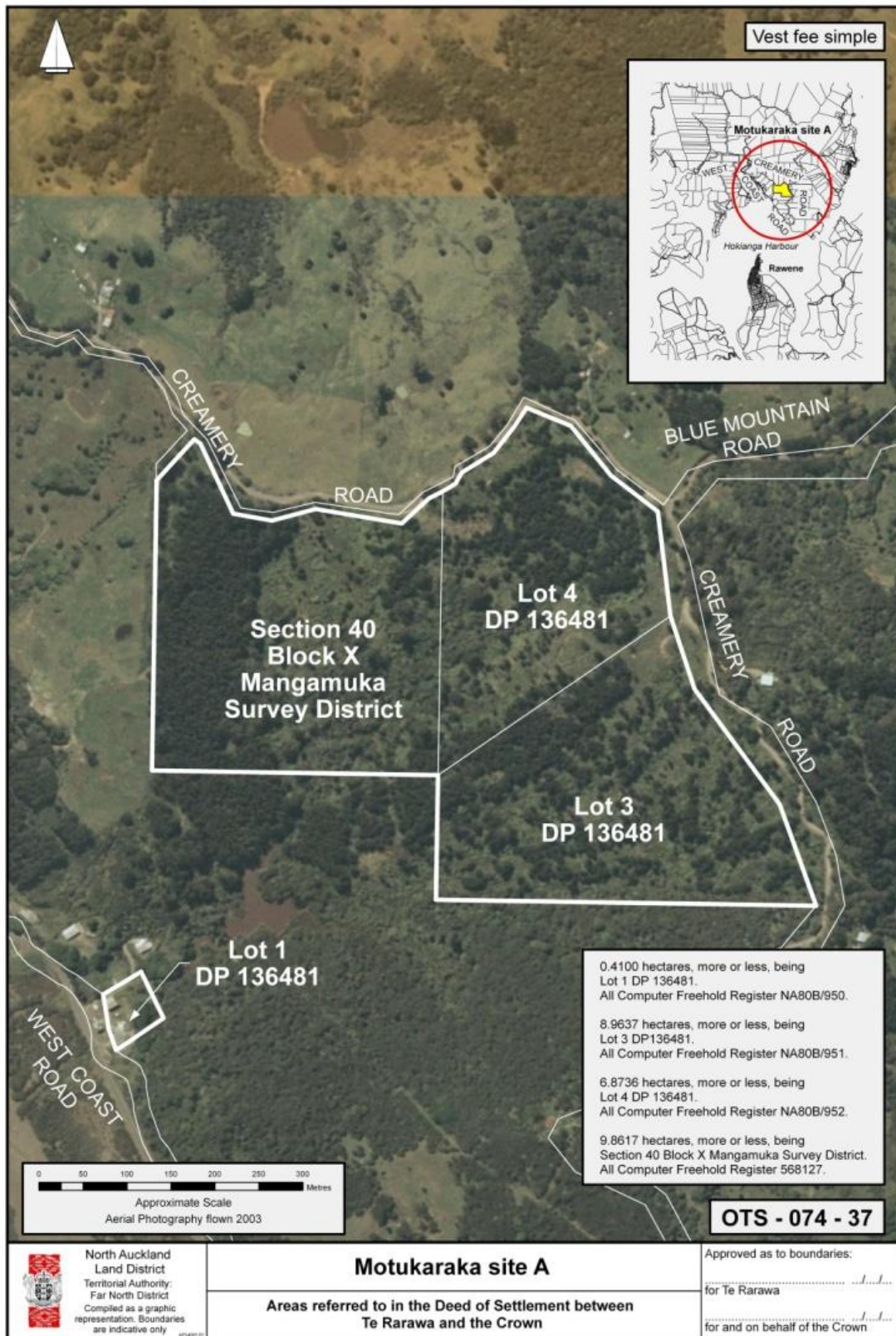

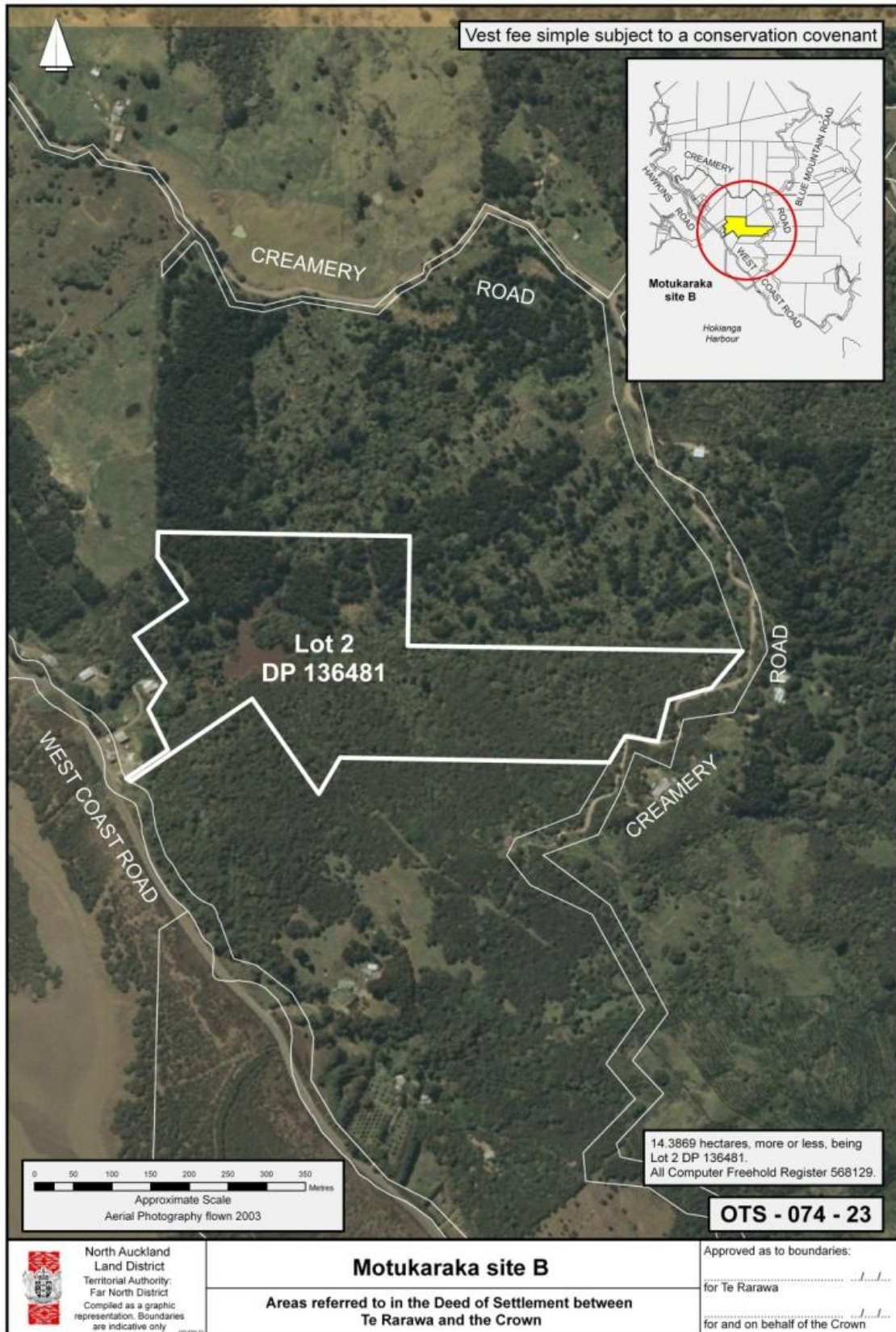
MOTUKARAKA SITE A (OTS-074-37)

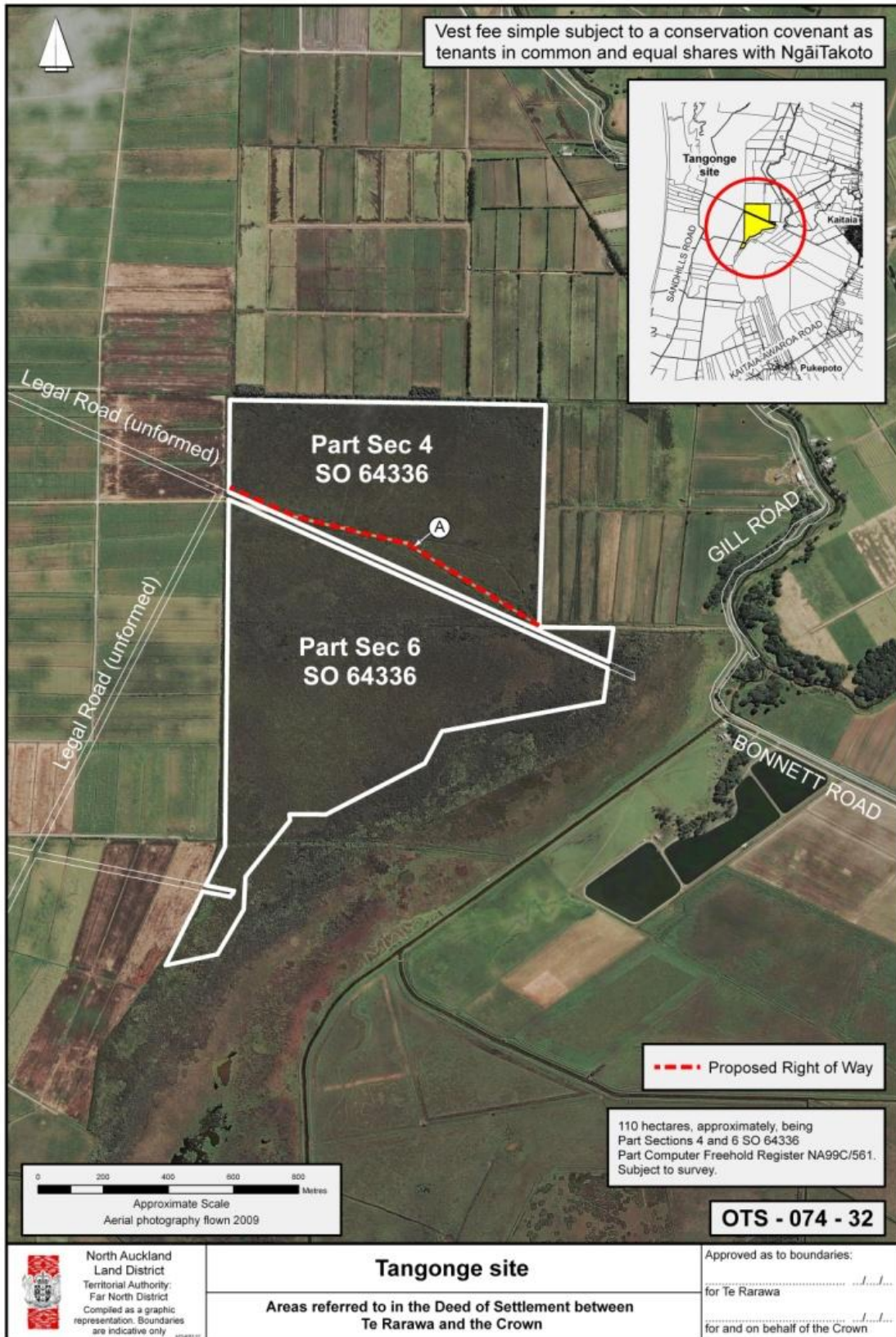

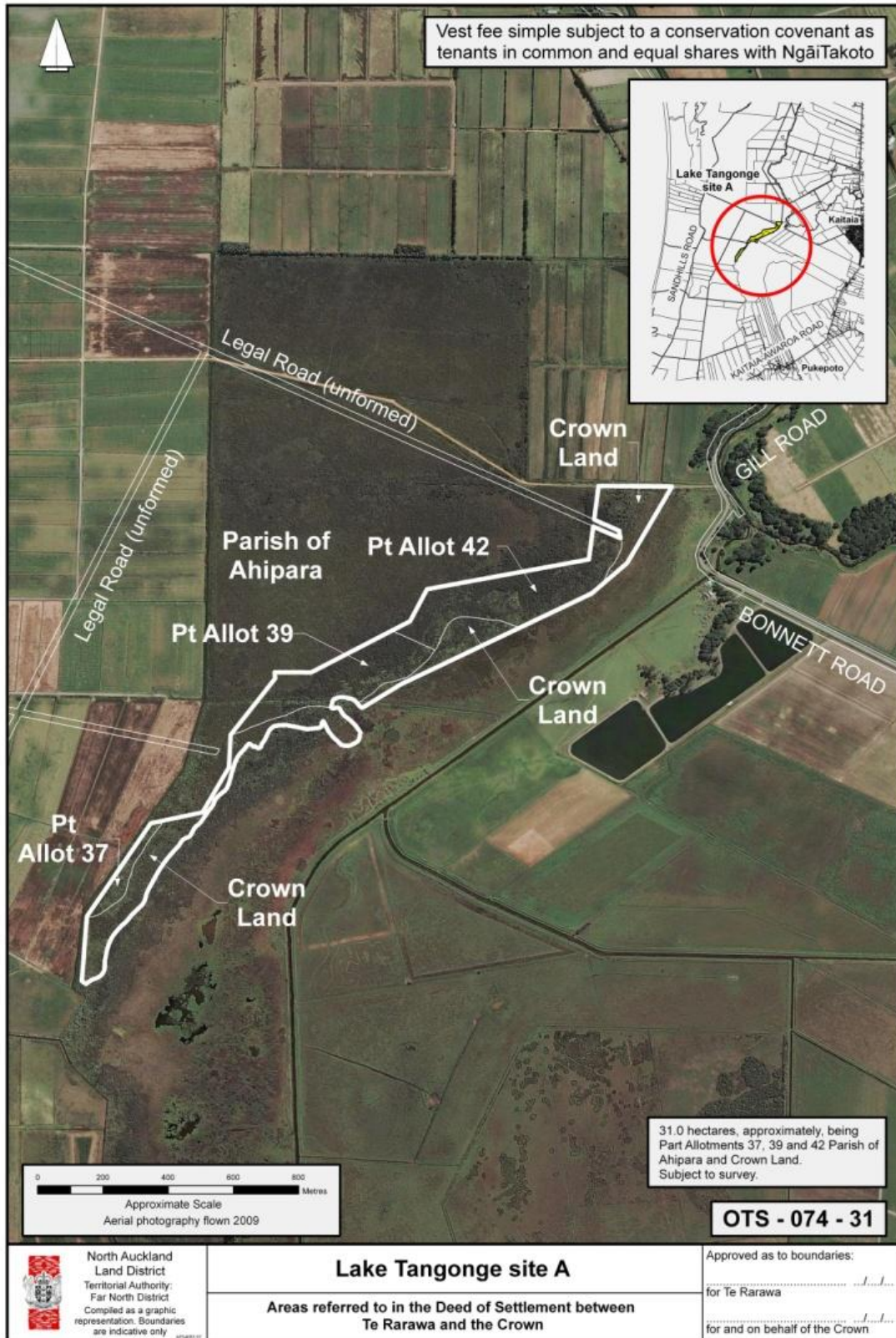

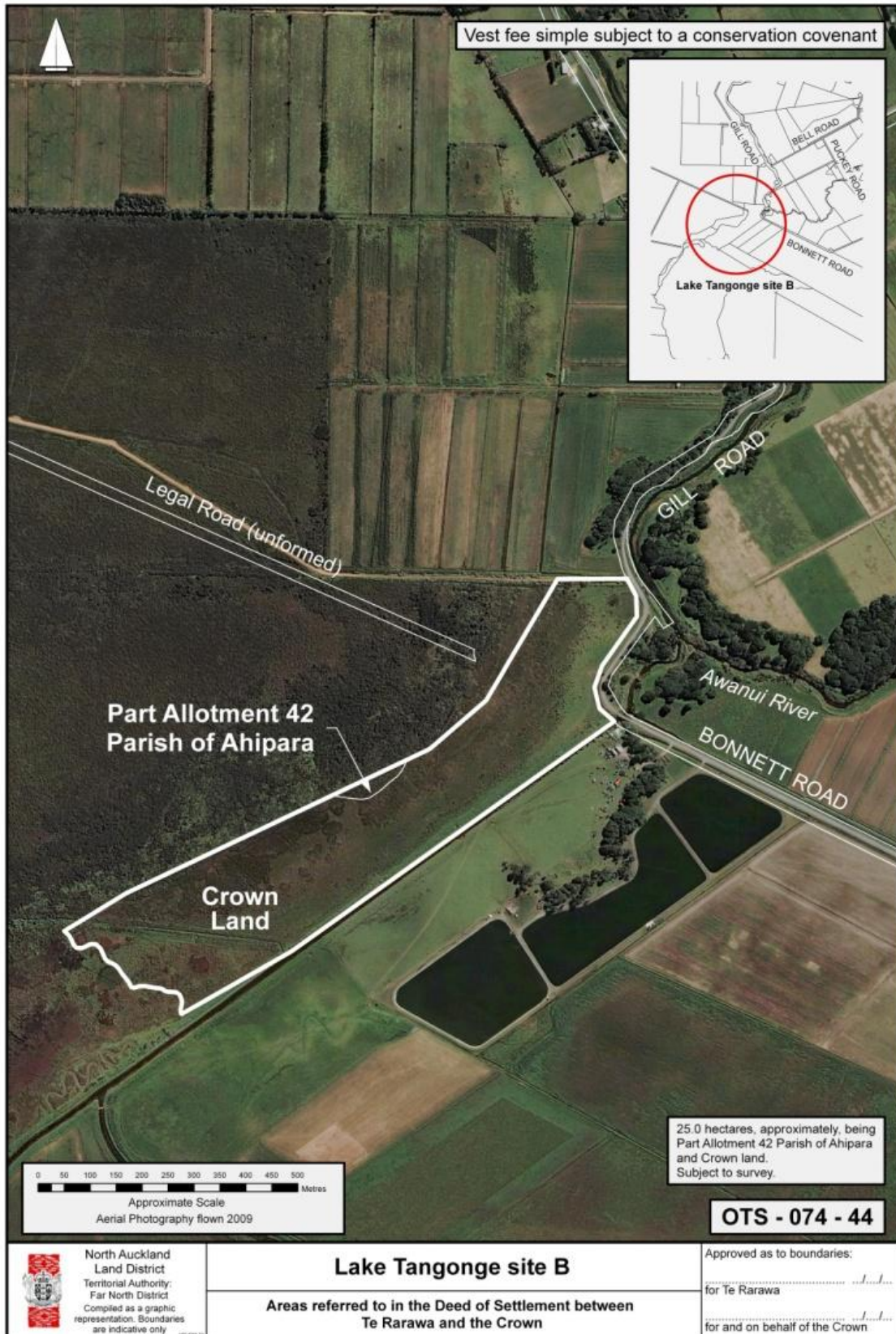
LAKE TANGONGE SITE A (OTS-074-31)

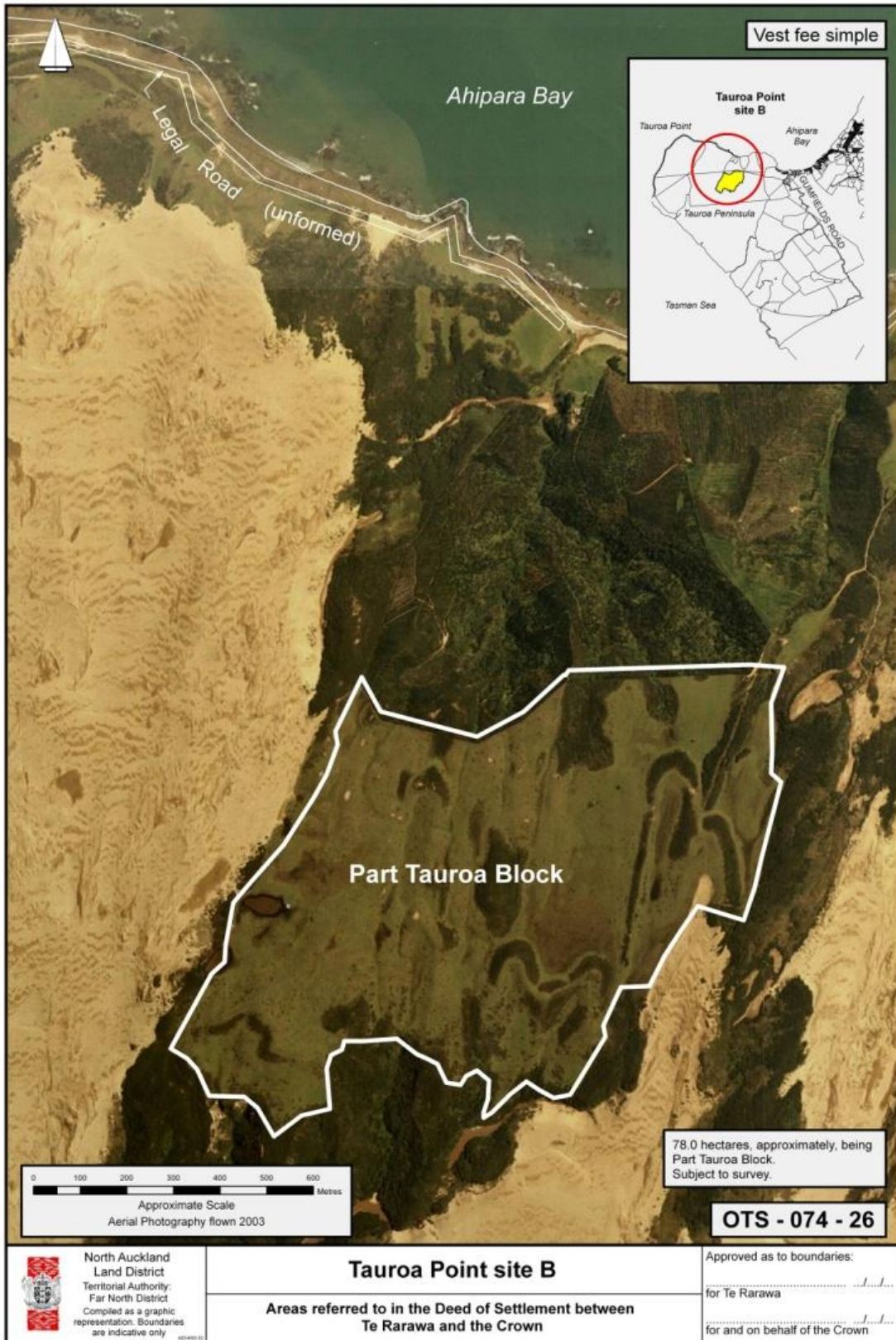
LAKE TANGONGE SITE B (OTS-074-44)

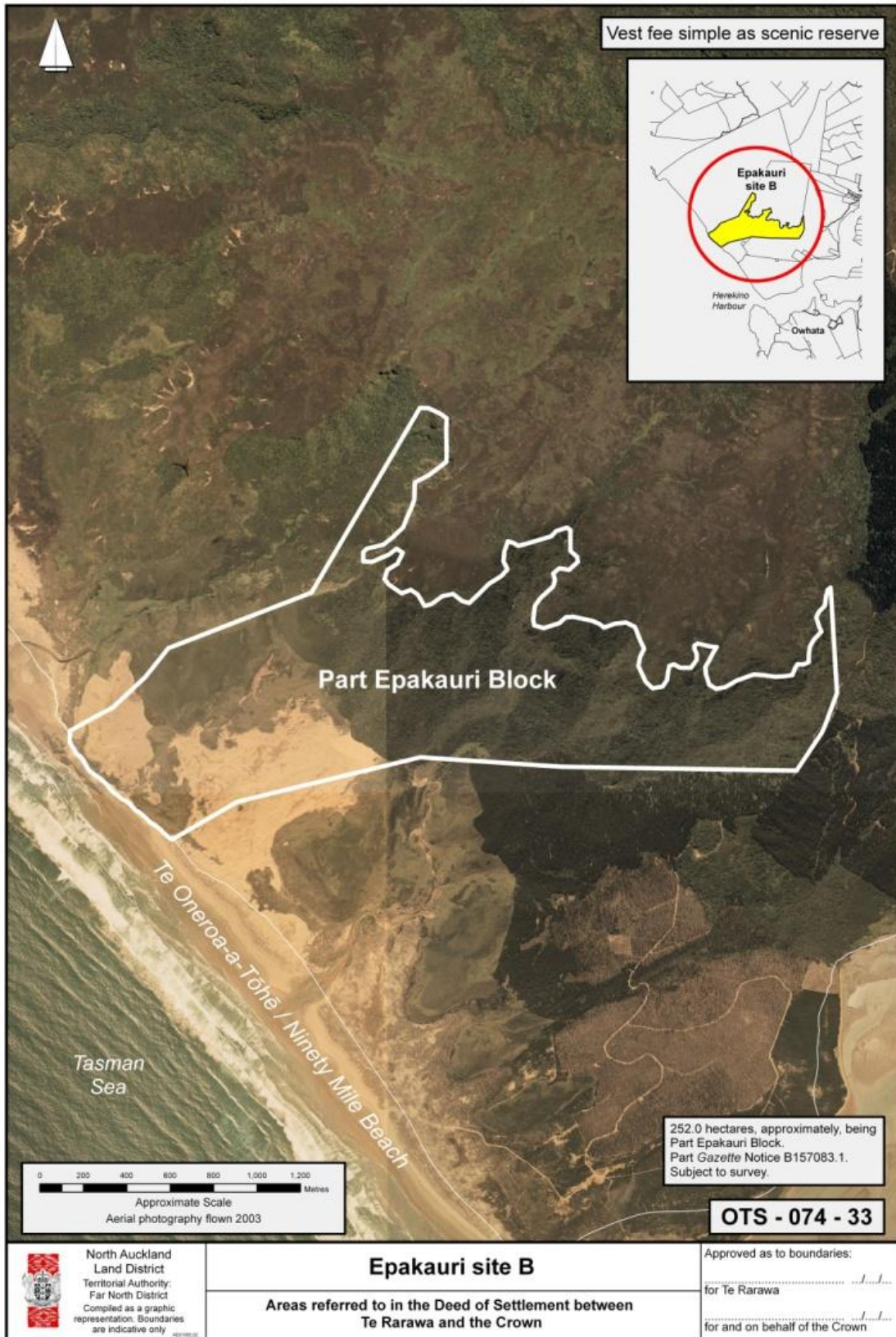
TAUROA POINT SITE B (OTS-074-26)

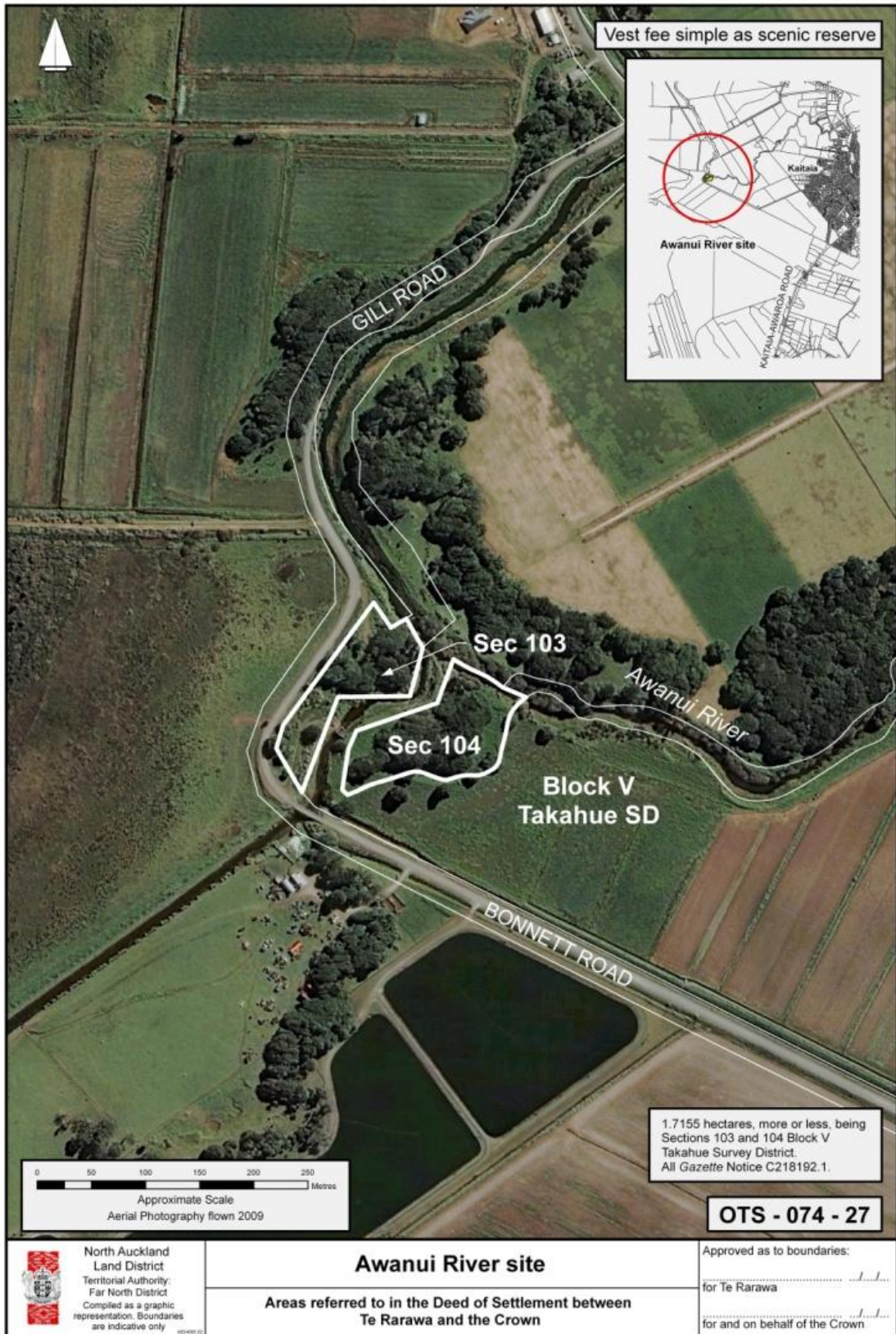
EPAKAURI SITE B (OTS-074-33)

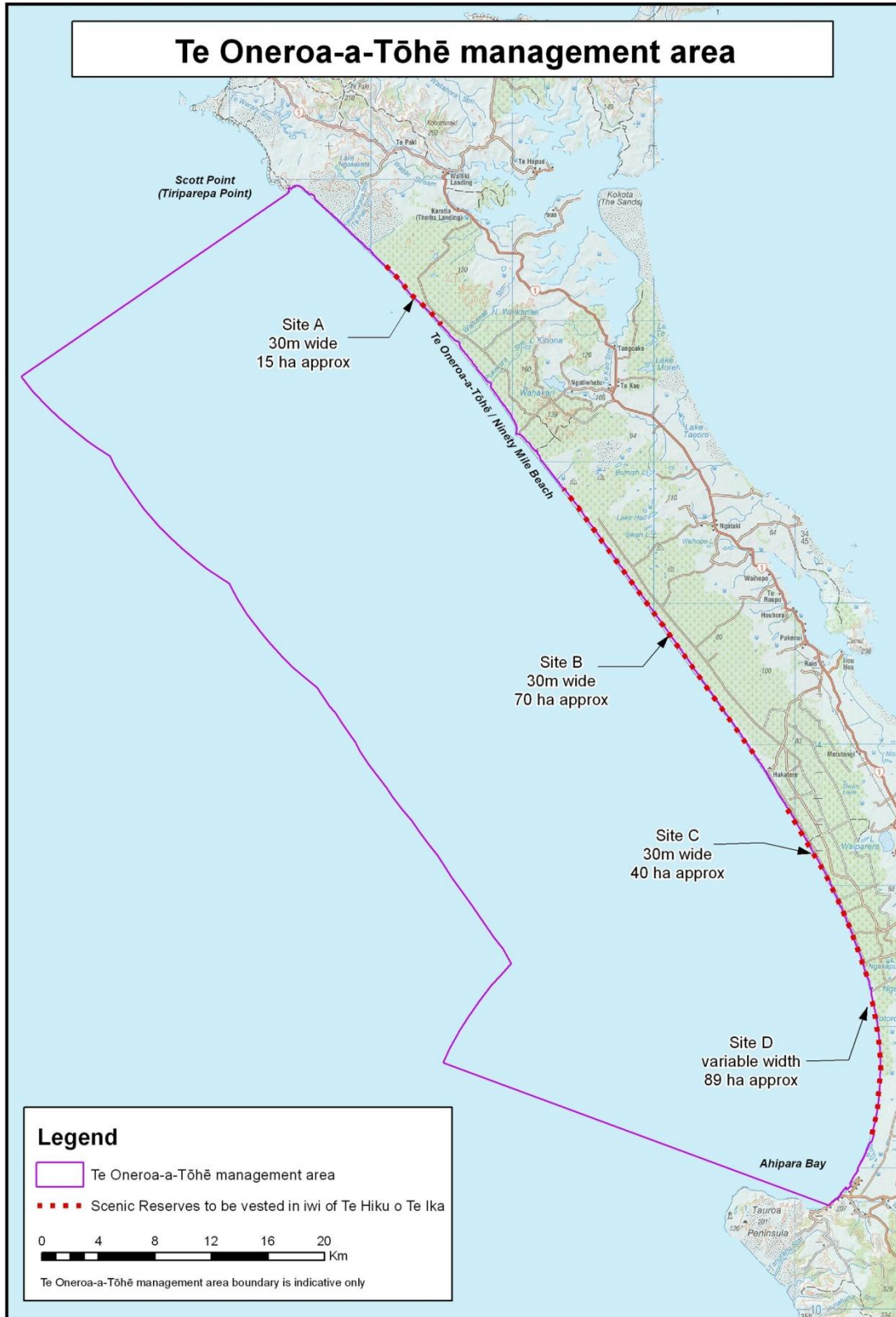

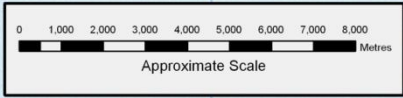
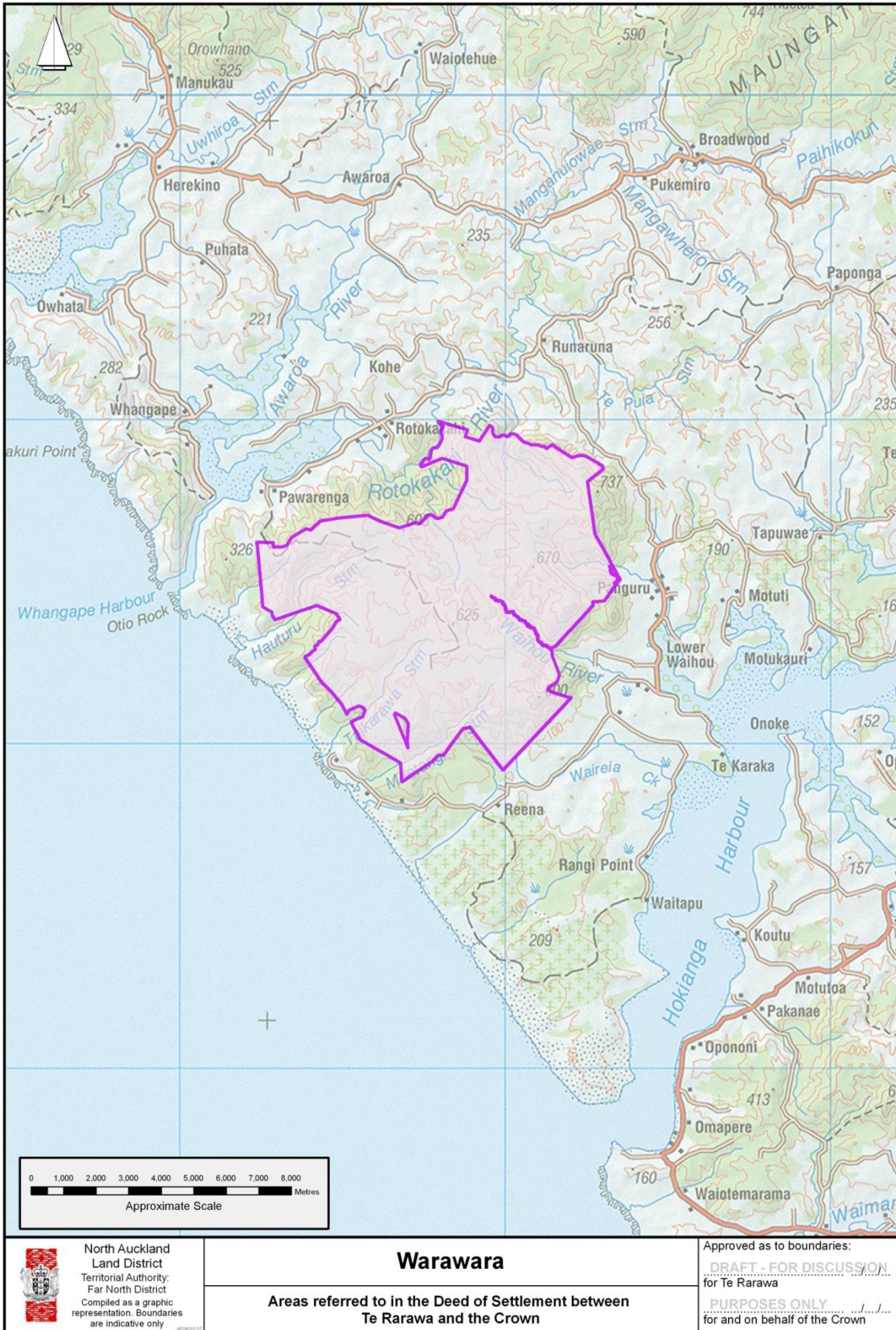

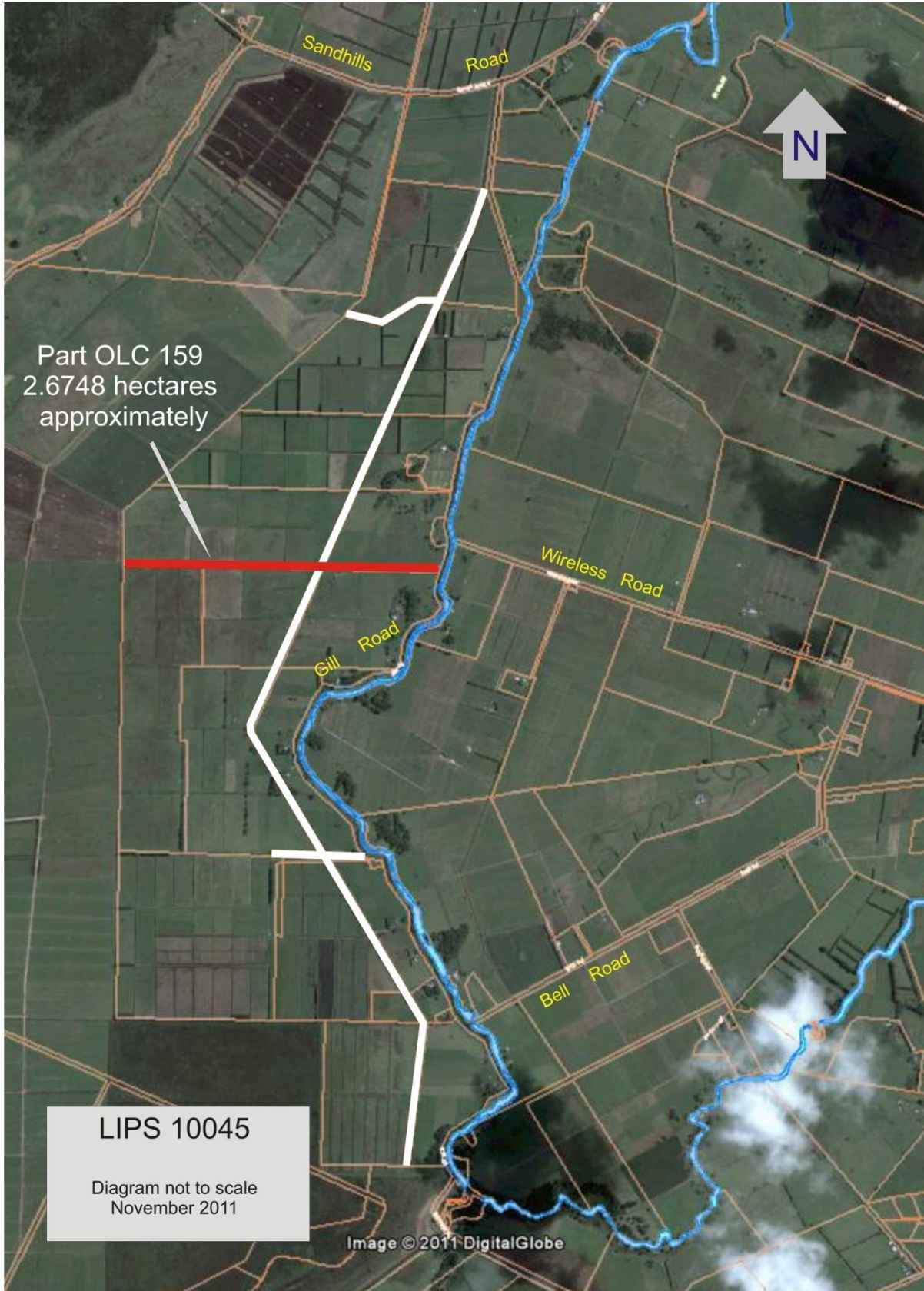

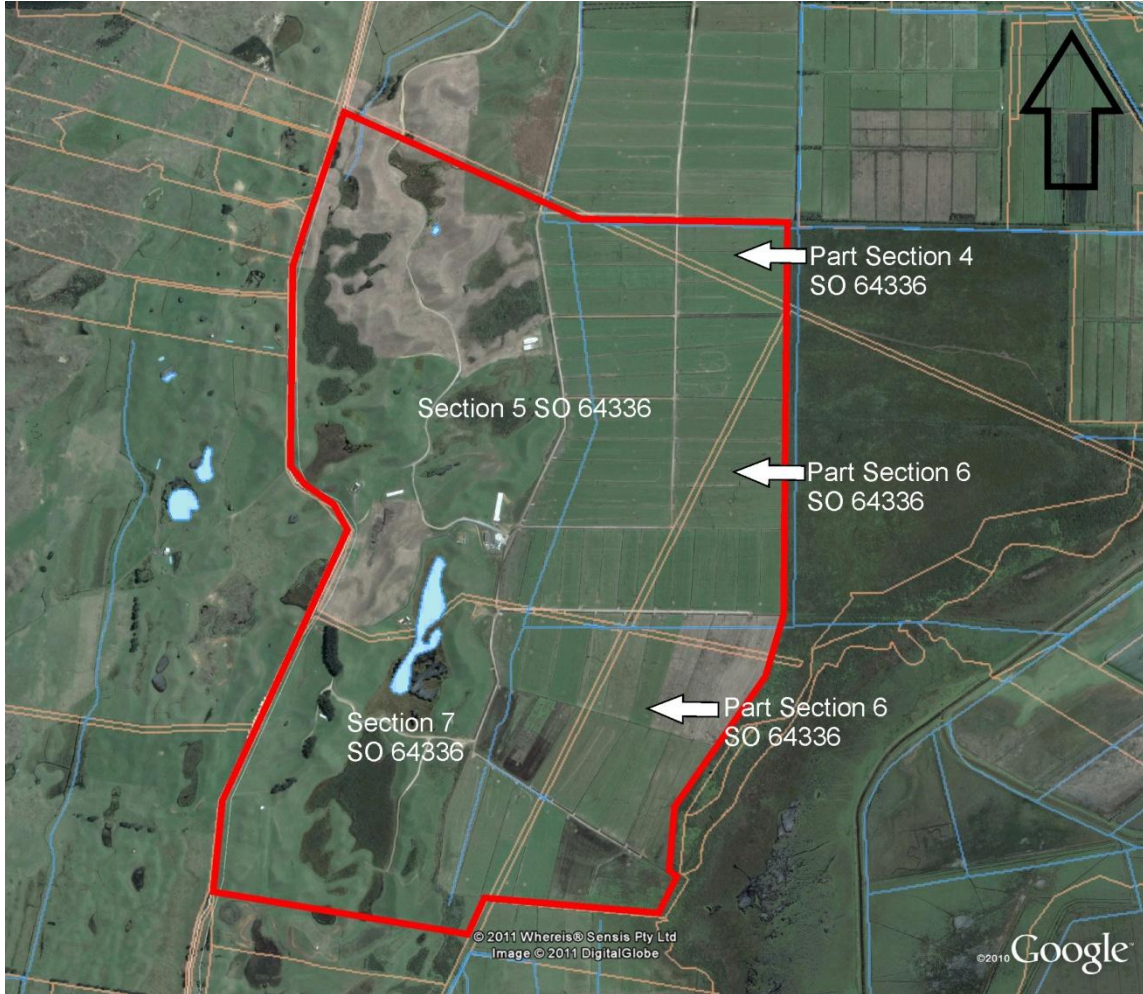

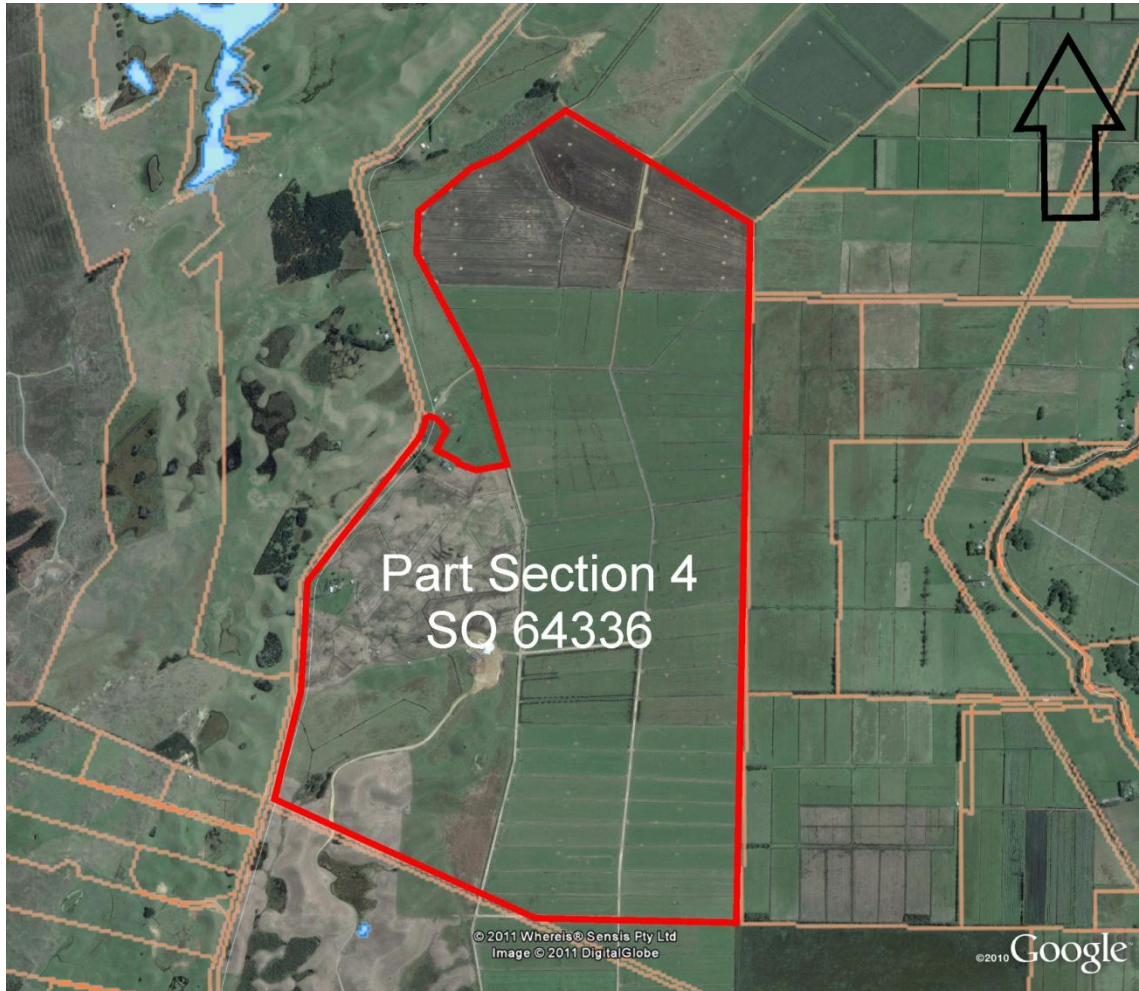
